COUNCILMAN JOHNSON moves that the Communication be Received and the Appointment Disapproved.

COUNCILMAN MANSOLILLO states: This communication for the term to succeed Mr. Duffy is based strictly on the Authority in the current Act. Any appointments, School Committee, Board of Park Commissioners and several other Boards are no longer in effect as of the first Monday in January of 1983; however, the authority in the current Charter for the current Act governing the School Committee stipulates that these terms be set forth.

There is no intent of the present Administration to circumvent the Charter coming into effect in January of 1983, because the current law governing the School Committee is in effect and the appointment is made pursuant to that Law. Mr. DeRobbio and his several colleagues on the School Committee are automatically out of office, on the first Monday in January regardless of their period of appointment. He sees no reason why Mr. DeRobbio should not become a Member of the School Committee with full approval of this body.

Councilman Pearlman requests a ruling from the City Solicitor on the question of the legal status of the appointment and the rendered term.

Acting City Solicitor Rotondi agrees with the interpretation as stated by Councilman Mansolillo that what is submitted before the Council this evening is a form situation and the new code that takes effect in January, 1983, states that

these particular individuals are no longer in the capacity that they are now seated in, therefore, agrees with Councilman Mansolillo.

Resolved, That His Honor, the Mayor is authorized with the recommendation of the Committee on City Property of the City Council to accept from the COMMUNITY LOAN AND INVESTMENT CORPORATION of Providence, Rhode Island that certain lot or parcel of land located at 136 Murray Street at the corner of Sophia Street in the City and County of Providence, and State of Rhode Island, laid out and delineated as Lot No. 146 on Assessor's Plat No. 109, and bounded and described as follows:

Beginning at a point in the southwesterly street line of Sophia Street, said point being a drill hole set four hundred forty and 00/100 (400.00') feet southeasterly of the intersection of the southwesterly street line of Sophia Street with the southeasterly street line of Ethan Street;

thence southeasterly in the southwesterly street line of Sophia Street a distance of eighty and 00/100 (80.00') feet to a steel pin set;

thence turning an interior angle of 90°-00'00" and running southwesterly in the northwesterly street line of Sophia Street a distance of nineteen and 23/100 (19.23') feet to a steel pin set at the point of intersection with the northeasterly street line of Murray Street;

thence turning an interior angle of 103°-50'-30" and running northwesterly in the northeasterly street line of Murray Street a distance of eighty-two and 39/100 (82.39') feet to a drill hole set;

thence turning an interior angle of 76°-09'-30" and running northeasterly, bounding northwesterly by land now or formerly of Anthony and Genny Piccirillo, a distance of thirty-eight and 94/100 (38.94') feet to the point and place of beginning, forming an interior angle of 90°-00'-00" with the line first described and containing 2,327 square feet.

Said land is to be accepted from the COMMUNITY LOAN AND INVESTMENT CORPORATION for use as a small tree-shaded, passive, sidewalk area to compliment the Street Tree Planting Program in the Silver Lake neighborhood.

Said property will be purchased solely with

funds from the Community Development Block Grant Program approved by the U.S. Department of Housing and Urban Development in the amount of Three Thousand Five Hundred (\$3,500.00) Dollars.
