(\$10,000.00) FROM WORKERS COMPENSATION (1-013-17-3-92)
TO LAW DEPARTMENT CLAIMS ACCOUNT (1-01-05-331),
AS AMENDED.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1983-30 of the Ordinances of the City of Providence, as approved July 10, 1983, entitled "An Ordinance making appropriation of One Hundred Sixty-Nine Million, Seven Hundred Ninety Six Thousand, Two Hundred Forty Dollars and Ninety-Six Cents (\$169,796,240.96) for the Fiscal Year ending June 30, 1983, as amended", is hereby further amended by transferring the sum of Ten Thousand Dollars (\$10,000.00) from Workers Compensation (1-013-17-3-92) to Law Department Claims Account (1-01-05-331).

SECTION 2. This Ordinance shall take effect upon its Passage.

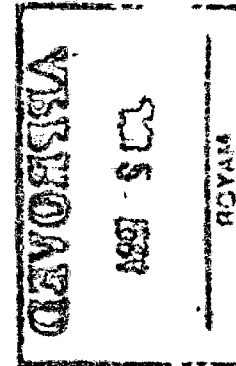

RE: CLAIM OF RICHARD A. CAMPAGNONE

I spoke to you about this claim a couple of weeks ago. Since this accident and injury occurred while Mr. Campagnone was working in the Sewage Treatment Plant on 4/23/82, Attorney Jerry Norigian, who handles Workers' Compensation claims for the City, felt that in terms of a finality to the claim, it would be better if it were settled as a straight claim by the Claims Committee.

I went along with this, upon condition that the claims' account of this department be reimbursed from the Workers' Compensation Account.

This was agreed to by Mr. Norigian and John Mancone, who was the Acting Personnel Director, and who is now Deputy Personnel Director.

Accordingly, I enclose herewith a copy of a letter from Mr. Mancone, authorizing the transfer and charge off of the said TEN THOUSAND (\$10,000) DOLLARS, from the Workers' Compensation Budget to the Law Department Claims' Budget.

Would you kindly take whatever steps are necessary to effect this transfer, and notify me when it is effectuated?
