
Gentlemen:

The Traffic Engineering Department has reviewed the proposed resolutions establishing Ringgold Street and Pallas Street, between Carpenter and Kenyon Streets, as one-way streets.

Both of these streets are 24-foot wide, and are only two blocks long. Therefore, they are not involved in arterial movement of traffic, but rather serve as local circulation streets in their immediate neighborhood. This department offers no objection to establishing these two streets as one-way streets, since no conflict would be created with over-all traffic patterns by making them one way. It would seem to be more a matter of local neighborhood preference, and a means of eliminating a certain amount of congestion and confusion which may arise on these relatively narrow streets, particularly in the winter time.

From the standpoint of present street usage it is recommended that Pallas Street be made one way in a northerly direction from Carpenter to Kenyon; and that Ringgold Street be made one way in a southerly direction from Kenyon to Carpenter Street.



Gentlemen:

The Traffic Engineering Department has reviewed the proposed resolution to establish Hannah Street as a one-way street from Amsterdam Street to Atwells Avenue.

This street is a very narrow street, being only 12-feet wide. In view of the narrow width of this street, and the congestion which can be eliminated at the intersection of Hannah, Atwells and Mount Pleasant Avenues, it is recommended that Hannah Street be made one way in a notherly direction from Amsterdam Street to Atwells Avenue.

Gentlemen:

The Traffic Engineering Department has reviewed the petition to establish O'Neil Street as a one-way street from Douglas Avenue to Veazie Street.


O'Neil Street is a one-block long street, 24-feet wide, with parking presently permitted on both sides of the street. This street serves as an extension of River Avenue, connecting to Veazie Street and Branch Avenue. While O'Neil Street is not, and should not be an arterial street, it does serve an important function as a connecting link between Douglas Avenue and Branch Avenue. If it were not for the use of O'Neil Street, traffic attempting to get from Branch Avenue in the vicinity of Veazie Street across to River Avenue would have to follow Branch Avenue to its intersection with Douglas Avenue and make a "U" turn in this intersection to travel back on Douglas to River; or do a similar roundabout maneuver using Veazie and Douglas.

It is therefore recommended that O'Neil Street remain as a two-way street.

With parking permitted on both sides of this relatively narrow street, there is a considerable amount of congestion, and if the parking is heavy on both sides, it is impossible for vehicles to pass going in opposite directions.

In view of the traffic movements that are taking place through this street, it is recommended that parking be eliminated on the south side of the street.
