Whereas, The Tax Collector has certified in writing to the City Council that such taxes in excess of \$1,446,042.74 are presently uncollectable and should be cancelled and abated;

Whereas, On May 24, 1979 in the Federal District Court for the District of Connecticut, Judge Zampano entered a decision and order on the City of Providence's Petition after hearing, which decision granted the City's petition and authorized the trustee to pay to the City of Providence \$1,446,042.74 in full and complete discharge of all tax claims against the Bankruptcy estate and debtor;
