## RESUME

Stanley Weiss is a Providence-based developer who has been involved with real estate in Providence for the past twenty years and before that, a Vice President at Citizens Bank where he is a graduate of the National Graduate Trust School at Northwestern University and a Certified Financial Counselor. He has graduated with Honors from Hunter College (B.A.—Sociology/Political Science) and has an M.A. from University of Michigan, under a Metropolitan Community research Fellowship; post-graduate work, Brown University in 1965, under a National Science Foundation Fellowship in Urban Sociology.

Mr. Weiss is currently a member of the Capital Center Commission, appointed and reappointed by three Governors. For more than a decade, he has been a trustee of the Providence Foundation. Stanley Weiss is also treasurer of the Providence Public Buildings Authority, reappointed by three mayors. He is also a trustee of the Providence Performing Arts Center. Prior to that, Weiss was Chairman of the Providence Review Commission and Commissioner on the Port of Providence.

Currently, Stanley Weiss is one of the principal real estate holders in the old retail core in Providence. He has been intimately involved in the revitalization and Renaissance of Providence. He has restored the Tilden-Thurber Bldg, now housing the Stanley Weiss Collection of museum quality antiques for which he is nationally recognized. He has developed Grace Park and the Hotel Providence, a 4-Diamond hotel. Further, he has also restored the Fletcher and Mason Bldgs., for the Rhode Island School of Design. All of these projects have been awarded Statewide Historic Preservation Certificates.

Prior to this, Mr. Weiss has developed a number of real estate projects before and during employment with Citizens Bank. He has been the Managing Partner of the University Heights shopping center/apartment complex in Providence. Of significance, he has also owned 55 Court St., a Boston office building, and a 351-unit apartment complex in New Orleans, LA, the hometown of Mrs. Weiss. All of Mr. Weiss's projects have had positive financial success and recognition.

Stanley Weiss is married and has two grown children. His wife Beth is a prior trustee of the Wheeler School and Temple Beth-El in Providence.
