



Thank you for bringing the pending City Council resolutions concerning the commemorative naming of the following street segments:

- Kenwood St. from Waverly St. to Messer St. to be commemoratively named as the "Avenida Republica de Honduras."
- Waverly St. from Cranston St. to Union Ave. to be commemoratively named as the "Avenida Republica Del Salvadore."
- Union Ave. between Waverly St. and Messer St. to be commemoratively named as the "Avenida Republica de Guatemala."
