Gentlemen:

A resolution of the City Council was submitted to the Bureau of Licenses relative to the authorization of the operation of games of skill in liquor establishments, which was taken up on April 27th at a conference held in the hearing room of the Bureau.

The consensus of opinion of the police officials was that, if the Bureau amends its regulations permitting the license holders to operate games of skill or any other games in their establishments, it would be almost impossible for the Police Department to enforce the law insofar as it pertains to gambling and other abuses. The Bureau feels it should cooperate with the Police Department in this regard.

Therefore, we respectfully recommend that the resolution be not adopted.
