Be it ordained by the City of Providence:

SECTION 1. Chapter 1974-19 of the Ordinances of the City of Providence, as approved June 19, 1974 entitled: "An Ordinance making appropriation of \$85,823,307.71 for the support of the City Government for the Fiscal Period Beginning July 1, 1974 and Ending June 30, 1975," as amended, is hereby further amended by appropriating Four Hundred Sixty Nine Thousand Eight Hundred Forty Five (\$469,845.00) Dollars as follows:
