RESOLUTION OF THE CITY COUNCIL

Approved December 14, 1979

RESOLVED, DECREED AND ORDERED:

That the portion of the following named street, shown as cross-hatched area on the accompanying plan entitled, "Providence, R.I., P.W. Dept.-Engineering Office, Street Line Section, Plan No. 064099 Dated October 30, 1979,"

viz:

Wendell Street (portion of) shown as cross-hatched area (A-B-C-D-A), having ceased to be useful to the Public and the same is hereby abandoned as a Public Highway and the damage to the abutters is appraised at nothing, and so awarded, subject to those easements incorporated in accompanying correspondence November 27, 1979 from City Engineer, a copy of which is hereto attached, also correspondence from the Acting Chief Engineer of Water Supply Board, a copy of which is hereto attached, correspondence from Narragansett Electric Company, which is hereto attached, also correspondence from the Providence Gas Company which is hereto attached.

ORDERED, That the Director of Public Works, be and he is hereby directed to cause a sign to be placed on the above-named street abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree, the City Clerk shall cause a notice, thereof, to be published in a newspaper published in the County of Providence at least once a week for three successive weeks, and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.

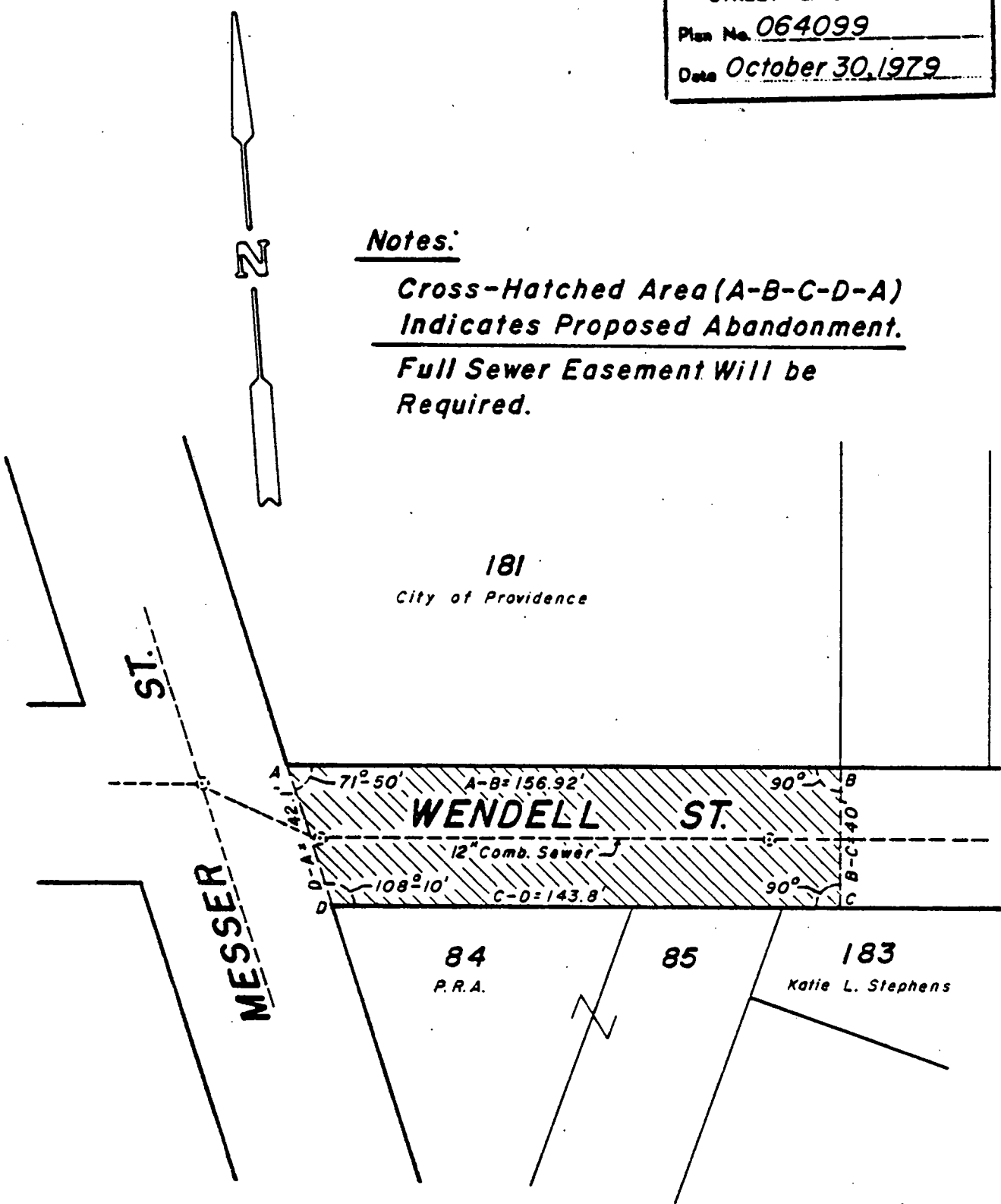



REFERRAL NO. 2019 - Abandonment of Portion of Wendell Street

A communication from the Committee on Public Works dated October 22, 1979 proposed the abandonment of portion of Wendell Street from Messer Street running easterly approximately 156 feet. The street area in question is 6,014 square feet. The petition was introduced to the City Council by the request of the School Department through Councilmen Pearlman and Farmer on October 18, 1979. It was referred to the Committee on Public Works.

A field inspection revealed that the aforesaid portion of Wendell Street is an improved public right-of-way within the R-4 Multiple Dwelling Zone. Asa Messer Elementary School is located directly at the northerly side of said portion of Wendell Street and 3 residential lots are located directly at the southerly side. The City is in the process to condemn that 3 lots for a new school building as an addition to the existing Asa Messer School and a new public right-of-way will be created to connect Wendell Street to Ford Street so that Wendell Street will not be created as a dead end street. The aforesaid portion of Wendell Street is within the West Broadway Renewal Project. The proposal to abandon that portion of Wendell Street with the provision of a new connector for traffic circulation should not have a detrimental effect on the surrounding neighborhood or the urban renewal plan for West Broadway Project. Therefore, it is recommended by the Department of Planning and Urban Development that the Commission advise the Committee on Public Works that no objection is offered on this petition subject to the approval of the City Traffic Engineer.

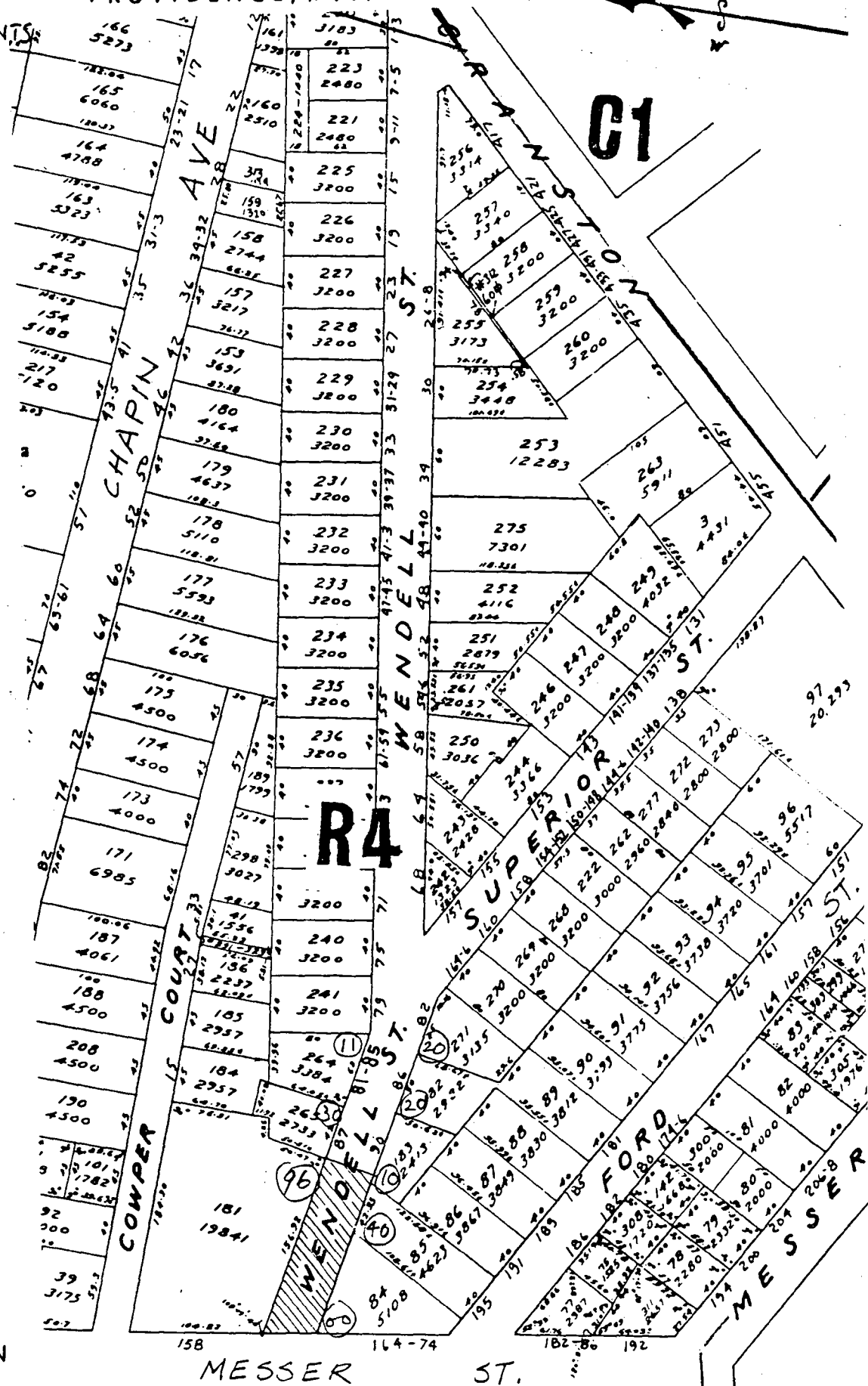





Dear Councilman Flynn:

On October 23, 1979 this department received from the City Clerk a memorandum and a copy of petition to abandon as a public highway a portion of Wendell Street.

In this portion to be abandoned we have a 6-inch C.I. water main and a 4-inch service to the school. This 6-inch main is connected into 12-inch feed main and reinforces all the easterly part from Messer Street. Cutting off this main would create a serious condition for fire protection in this area and also degrade the water supply for this area.

Possibly an easement would be an alternate consideration.


