CHAPTER 1976-34

No. 389 **AN ORDINANCE** in amendment of and, in addition to Chapter 853 of the ordinances of the City of Providence, approved May 20, 1954, and entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the Willard Center Unit Two Project Area D2-A2," as amended.

Approved August 4, 1976

Be it ordained by the City of Providence:

WHEREAS, on May 20, 1954, the City Council of the City of Providence adopted and approved by Chapter 853, No. 299 of its ordinances, the Official Redevelopment Plan for Willard Center Unit Two Project Area D2-A2; and

WHEREAS, said Plan required among other things that a playfield to serve older youth and young adults is proposed to center in the area south of the playground and school site and extends southerly to the project area boundary along Pilgrim Street; and

WHEREAS, the City, subsequent to the passage of the aforementioned ordinance, did construct on that portion of the land within the Willard Center Unit Two Project Area, a playfield in accordance with the terms of the aforementioned Redevelopment Plan; and

WHEREAS, it is now determined that said playfield area in addition to use for a playfield is also useful for an erection of an OIC (Opportunities Industrialization Center) Building owned and operated by Opportunities Industrialization Center of Rhode Island, Inc.

NOW, THEREFORE, be it ORDAINED by the CITY OF PROVIDENCE

That Chapter 853 of the Ordinances of the City of Providence, approved May 20, 1954 and entitled "Ordinance Approving and Adopting the Official Redevelopment Plan for the Willard Center Unit Two Project Area D2-A2" as heretofore amended be and the same is hereby amended as follows:

1. Any and all reference to the use of a portion of the land in the project area exclusively for a playfield be and the same is hereby deleted.
2. That the said portion of the land within the project area be and shall henceforth be used as a playfield and be permitted for an erection of an OIC Building.
3. That for the said portion of the land within the project area, the permitted uses, building height, building coverage, density, building set-back, off-street parking and loading shall be governed by the applicable provision of the Zoning Ordinance as amended to date.
4. That Chapter 853 of the Ordinances of the City of Providence as adopted and as heretofore amended be and the same is hereby ratified and confirmed in all other respects.
5. That this Ordinance shall take effect upon its passage and all portions of said Chapter 853 of the Ordinances of the City of Providence inconsistent herewith are hereby repealed.








PROJECT LOCATION AND RELATIONSHIP TO LOCAL OBJECTIVES

IN ACCORDANCE WITH THE MASTER PLAN




