## PERSONAL EXPRESSION

**COUNCILWOMAN NOLAN requests the privilege of the floor to speak on a point of personal expression and states:**

"Today, usually when I get up in the morning when I am ready to leave, go to Dunkin Donuts and I get my cup of coffee and I pick up my newspaper and today I read the Metro Section, there are a couple of things that almost drove me back, you all know that I've been doing the non violence thing, it almost drove me back to my old habits of violence. I'll say a couple of quotes "I wish I could stay, but the voters gave me \$50 million dollars to spend last night and I am going right down to my office to spend it". A statement made in jest I'm sure. Another quote, "Phyllis

Tennian described last night's vote in which she said only 30 of the 1,400 members in attendance dissented as a necessary spur to the stalemated contract talks. She said the intention was not to hurt the students but to remind school officials of teachers worth. If you respect the job that somebody does, she said, then you should pay them adequately to do it". Arthur Zarella said "work-to-rule really hurts just the children".

As I mentioned, these are some quotes out of the Providence Journal a newspaper on my... that doesn't even bother to cover our Council and Committee Meetings any longer because I guess we are not as important as East Providence.

The teachers for the most part have my respect, I cannot say the same for the teachers union. Respect goes both ways and I believe that you have to earn respect. Work-to-rule does not beget respect, it only makes parents mad, holding children and reforms as hostages does not gain respect from me or from any of the people of the City of Providence. It makes us mad. It makes us mad if we have a high school student who needs a letter of recommendation for college and cannot get one because of work-to-rule. It makes me mad that I and many others like me who have spent the last four years working on School Reform only to see it fall by the wayside. The teachers excuse themselves by saying that work-to-rule is only one of the methods used to jumpstart contract talks. I say, sure, you can have a raise, just show me where in your contract you can fill that amount of money because the City does not have the money for raises and even if the Administration gives in and negotiates a raise, without any give backs, the contract still has to get passed by the Council's ratification process and really, after work-to-rule, it doesn't put me in a mindset to ratify any such contract.

On the other issue concerning the \$50 million dollar bond, I went out and sold this issue to my neighborhood by saying the money would be used only for the neighborhoods. My people came out and worked all day and all night at the polls pushing for old No. 9 and some even wrote letters to the Editor in support. But by God, I will not

sit back and spend the money on repairing the Police Station as I read in the paper today. I know we just went out for bonding for a Million Dollars to repair the Police Station. So what are we doing here, double dipping? The last time that I looked, the Police Station is located Downtown and before I vote to draw down a dime I want a detailed written document showing me exactly how the money will be spent. I don't call the meetings we had with Parks Planning and DPW exactly productive. All they had were general ideas on how to spend the money. Hey, I could come up with a general plan and I don't have a degree in urban planning or urban studies. When I asked which streets would be repaved, they come up with one, Broad Street, which borders three Council Wards. Not acceptable. My interior streets have not been paved in God knows how many years and sidewalks, they supposedly looked up the outstanding applications in my Ward and only found 200. Sorry guys, not acceptable. You spend \$2 Million Dollars here, \$2 Million Dollars there, \$3 Million Dollars here, another \$2 Million Dollars there and pretty soon . . . and when Councilwoman Nolan calls up and says hey, when are you going to start in Ward 9 and the powers that be or I should say that the Planning powers that be say, oh, sorry Councilwoman but we have had these special projects and unfortunately, we ran out of money. Over my dead body! Thank you."
