## PERSONAL EXPRESSION

**COUNCILMAN CLARKIN requests to speak on a Point of Personal Expression and states:**

"In the last two years, we gave to the Civic Center funds from the City totaling over \$1,200,000. This year they want \$700,000. Three quarters of a million dollars.

Three quarters of a million dollars from the Providence Taxpayers again. They can't fund their own operation without coming hat in hand to the City for more funds.

A few years ago, a surcharge was added to the sale of tickets and this was to allow the Civic Center to pay back to the City the moneys they

owe us. They haven't done this. The Civic Center is a financial hole that can't seem to be filled.

The last union contract was the last straw for me, the giving of longevity pay raises, the increasing of vacation time, the increase in union pension payments and the lifetime Blue Cross payments and the lifetime Blue Cross after ten (10) years. They can't pay the bills without asking for more from the taxpayers, but, they can give away funds that they don't have.

This was the year to cut back, not to give away that which you don't have. It is my felling that it is time to privatize the Civic Center. Let some organization take it over and run it like a business. Let us put out to the private sector to see if there are any people that are willing to take this over and to run it right.

Our whole budget for the Recreation Department is just over 1 million dollars. We serve all the children and seniors in this City with a million dollars but are asked to give another \$700,000.00 to the Civic Center. It is time to say No to the Civic Center."

**COUNCILMAN DeLUCA requests to speak on a Point of Personal Expression and states:**

"Recently, I went away on a little vacation and I usually take some reading material with me when I go and I usually get a science fiction book at the drugstore. I always do that but this time I didn't, they didn't have much in the science fiction area so I brought the City Budget with me and I was glancing over it and quite a few things did catch my eye.

We have believe it or not, a man in charge of the Carpenter Shop at the Fire Department and also a Superintendent of the Carpenter Shop and mind you I am not picking on the Fire Department, but anyway, the man in charge of the

Carpenter Shop in 1994 was making \$40 some odd thousand dollars. His Supervisor at the Fire Department's Carpenter Shop — according to the personnel ordinance — he was making \$50 some odd thousand dollars, about \$10,000.00 more. Then their budget, because we rejected it, and it has been rejected, those two individuals went from the \$40 thousand position from man in charge of the Carpenter Shop (see page 7 of the ordinance) went to \$42 some odd thousand dollars and he got a \$2,000.00 raise and his superintendent went to \$61 some odd thousand dollars and he got a \$10,000 raise. More than 20% of his pay and this is in one year, in one year! Well, he must be one hell of a Carpenter!

However, that is this year's budget, but there is a new and a more important budget that we have to look at and the pay scale stays the same for this poor carpenter who is making \$61 some odd thousand dollars a year.

Looking at the classes of positions and all of these pages, there is two pages of positions and pays on legal size paper and they are another food for thought.

This also refers to temporary employment and this has been around in the same ordinance for quite a while and at the end of the Ordinance there is a note that says the Finance Director . . . and hire them on a temporary basis . . . for five year" and it should be reading "should not . . . exceed thirty (30) days" and the City Council approved this.

This legislative body is the only legislative body that can spend money. This is illegal without the City Council's approval and that means that there are contracts involving money and are null and void without City Council approval and that is why were are here, to protect the funds.

Back to the budget, the current fiscal year ends June 30, 1995. The City of Providence it contains . . . the Finance Director, oh, he is doing his job and he is telling us . . . about collection rates on the taxes, etc.



Once again, for the third consecutive year, Section 812 of the City Charter is being violated. Where is the Capital Budget? Section 812 entitled "Capital budget which states "At the same time that the Mayor submits the operating budget to the city council, the mayor based upon estimates and recommendations of the city plan commission as provided for in Article X, Section 1013 shall prepare submit to the city council a capital budget for the ensuing fiscal year and the next four (4) fiscal years thereafter. Said capital budget shall embody the mayor's estimates of cost and

recommendations of means of financing each project contained with the capital improvement program, provided that no project shall be included in said budget which has not been favorably considered by the city council. In acting on the capital budget, the city council may accept, reject or modify the projects described therein or the proposed methods of financing the same.

I have no more jokes Madam President and no more food for thought. Thank you."
