



# RESOLUTION OF THE CITY COUNCIL

Approved July 12, 1999

**RESOLVED**, that His Honor the Mayor, is authorized to execute an easement agreement between the City of Providence by and through the Water Supply Board and Major Construction Associates., LLC. for one (1) perpetual easement, totaling 2,500 square feet in area, located in the City of Cranston in an area known as Quail Ridge Estates ( Assessor's Plat 26, Lot 5 ), for the amount of seven thousand five hundred dollars (\$7,500.00) dollars contingent upon indemnification of the Providence Water Supply Board and the City of Providence by Major Construction Associates, LLC and upon other such terms and conditions as have been imposed by the Water Supply Board, the City Council and His Honor, the Mayor.

Be It Further Resolved, that granting of this easement is contingent upon the relinquishing of two (2) presently exiting perpetual easement across the same City Property, totaling 6,250 square feet in area, by Major Construction Associates., LLC. to the City of Providence by and through the Water Supply Board.
