RESOLVED, DECREED AND ORDERED, That the portion of Maria Street, from the northerly line of Tingley Street to its northerly termination, shown as cross-hatched area and designated by the letters A-B-C-D-A on the accompanying plan entitled, "Providence, R. I., P. W. Dept.-Engineering Office, Street Line Section, Plan No. 063261, Date March 26, 1969", has ceased to be useful to the public and the same is abandoned as a public highway and the damage to the abutters is appraised at nothing and so awarded and it is further

ORDERED, That the Director of Public Works, be and he is hereby directed to cause a sign to be placed on that portion of Maria Street, from the northerly line of Tingley Street to its northerly termination, abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting that portion of Maria Street, from the northerly line of Tingley Street to its northerly termination, which has been abandoned, who is known to reside within this State.

## PETITION TO THE CITY COUNCIL

TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

*The undersigned respectfully petitions your honorable body*

1. That the petitioner has acquired two certain parcels of land in the City of Providence situated between Harris Avenue and Tingley Street and between Tingley Street and Kinsley Avenue.

2. That there has heretofore extended from the northerly line of Harris Avenue northerly across the said land acquired by the petitioner a public highway known as Mary Street, also sometimes known as Maria Street, as shown on that plat entitled "Plot of land belonging to Charles Potter Situated between Atwells Av and the Woonasquatucket River by N. B. Schubarth May 1854" which plat is recorded in the Office of the Recorder of Deeds of the City of Providence in Plat Book 4 at page 31 and (copy) on Plat Card 114.

3. That pursuant to the petition of the petitioner's predecessor in title, Arrow Transportation Co., Inc., the City Council did by Resolution No. 51 approved on January 21, 1969, abandon as a public highway so much of said Mary Street as extended from the northerly line of Harris Avenue to the southerly line of Tingley Street.

4. That the remainder of said Mary Street from the southerly line of Tingley Street northerly to its terminus south of the southerly line of said Kinsley Avenue accordingly remains a public highway although, like the portion heretofore abandoned, said street has never been used by the public and has always been used by owners of the land surrounding the same, and real estate taxes have been paid thereon by the predecessors in title of the petitioner.

5. That the existence of the remainder of said Mary Street as a public highway constitutes a cloud on the petitioner's title.

WHEREFORE the petitioner prays the City Council to determine that said Mary Street, also sometimes known as Maria Street, has ceased to be useful to the public, to order the abandonment of the same as a public highway, and to take such further action as it shall deem to be desirable.

SUBJECT: Referral No. 1727 - PETITION FOR ABANDONMENT OF PARCEL OF LAND BETWEEN  
TINGLEY STREET AND KINSLEY AVENUE

Gentlemen:

This referral from the Committee on Public Works is a request for the abandonment of a parcel of land 50' x approximately 475' running roughly north to south through Lot 36 in Assessor's Plat 27 between Tingley Street and Kinsley Avenue. This parcel was once known as part of Mary Street (reference - Plat Book 4, Page 31 dated 1864 in the Office of the Recorder of Deeds of the City of Providence.)

An inspection and photographic survey revealed that Lot 36 contains a large industrial building with facilities for truck storage on the Tingley Street side. The area is industrial in nature.

Attention is directed to the record of the Commission's action on Referral No. 1703 dated 11/19/68 (copy attached) which records the recommendation of the Commission for abandonment of another portion of Mary Street which was subsequently carried out by the City Council viz Resolution No. 51 approved 1/21/69.


If it can be legally established that the City of Providence has some claim to this property as a public highway no objection is offered to its abandonment for the purpose of clearing the title with the following provision.

It is recommended that the phrase "from the southerly line of Tingley Street" in paragraph 4 of the petition be changed to "from the northerly line of Tingley Street" to preclude the abandonment of any part of Tingley Street.





SUBJECT: Referral No. 1737 - PETITION FOR ABANDONMENT OF McCALL'S COURT

Gentlemen:

This referral from the Committee on Public Works is a request for the abandonment of McCall's Court which (according to Davis and Clark Plat #1 as shown on Plat Card 325 in the Office of the Recorder of Deeds concerning the estate of Mrs. Sarah Beaton platted in 1861 and replatted 2/25/1874) was once located on a strip of land 20 feet wide which runs from Douglas Avenue to Chalkstone Avenue. The route followed by McCall's Court runs over land now included in Lots 51, 52 and 56 in Assessor's Plat 68 (see accompanying map).

A photographic and inspection tour determined that there remains no visible evidence of the existence of McCall's Court. The neighborhood is in generally run-down condition.

Attention is directed to referral No. 1723 dated 4/9/69 which is a petition to change the zoning of this property from R-4 to C-4. No objection to the proposal was offered by the City Plan Commission. However, the City Council has not, as of this date, given final approval to this zone change.

Since the publishing of Plat Maps showing this land as part of Lots 51, 52 and 56 in Plat 23 in effect negates the continued existence of McCall's Court.
