## CHAPTER 764

No. 552 AN ORDINANCE amending Sec. 162.2 of Chapter 2 of the Providence City Ordinances, Article XV, relative to standard hours of employment.

Approved August 7, 1953

*Be it ordained by the City of Providence:*

Section 1: Sec. 162.2 of Chapter 2 of Providence City Ordinances entitled "Administration", "Article XV, offices and employees generally", is hereby amended to read as follows:

"Sec. 162.2 same - standard hours.

"The standard hours of employment in any one work week for all permanent employees of the City of Providence, except watchmen, standby emergency men and School Department employees, whose pay is established on an hourly basis in the City Compensation Plan shall be 40 hours: provided, however, that the standard hours of employment in any one work week shall be 45 hours for such employees as are engaged in Public Works Sanitation Division Garage and day street cleaning activities; and provided further that the standard hours of employment in any one work week shall be 48 hours for such employees as are engaged in night street cleaning, sewage disposal, garbage disposal, Ernest Street Pumping Station and Chapin Hospital activities."

Sec. 2. This ordinance shall take effect upon its passage.

SECTION 1: Chapter 666 of the Ordinances of the City of Providence as approved September 22, 1952, and entitled "An Ordinance Making Appropriation of \$28,328,060.70 for Support of the City Government for the Fiscal Year Ending September 30, 1953, as amended, is hereby further amended by adding the sums listed to the following appropriations:

Water Fund - Source of Supply, Item 0	3,168.52
Water Fund - Transmission and Distribution, Item 0	3,801.14
Water Fund - Meter Division, Item 0	1,466.27

SECTION 2: The said sum of Eleven Thousand Three Hundred Eighty-Seven (\$11,387.54) Dollars and Fifty-Four Cents as thus added and appropriated shall be obtained by transferring a like amount from Water Fund - Payment to Sinking Fund, Item 8.


