It is enacted by the General Assembly as follows:

1 SECTION 1. Section 41-5-2 of the General Laws in Chapter 41-5
2 entitled "Boxing and Wrestling" is hereby amended to read as follows:

3 41-5-2: Sunday boxing prohibited. -- In no case shall any boxing
4 or sparring match or exhibition, whether or not exempted under section
5 41-5-1, occur on Sunday. Provided, however, that the commission may
6 grant licenses for wrestling matches in the city of Providence on
7 Sunday.

8 SECTION 2. This act shall take effect upon passage.
