The following Ordinance was in City Council
December 20, 1979, Read and Passed the First
Time, and Is Returned for Passage the Second
Time:

An Ordinance in Amendment of the Code of Ordinances of the City of Providence, Section 12-54 Entitled: "Permit to Owner to Use Land as Dumping Ground" and Section 12-55 Entitled: "Permits, Regulation of Use of Dumping Ground."

Be it ordained by the City of Providence:

Section 1. Section 12-54 entitled "Permit to owner to use land as dumping ground" and Section 12-55 entitled "Permits, regulation of use of dumping grounds" of the Code of Ordinances of the City of Providence, is hereby amended by deleting the words "Superintendent of Health" and placing in lieu thereof "Director of Public Works."

Sec. 2. This Ordinance shall take effect upon its passage.

An Ordinance Creating the Department of Maritime Services of the City of Providence and Repealing Sections 11-18 and 11-19 of the Code of Ordinances of the City of Providence.

PRESENTATION OF RESOLUTIONS

COUNCILMAN FLYNN and COUNCILMAN DILLON:

Resolution Requesting the City Solicitor to Cause to be Introduced and to Urge Passage at the 1980 Session of the General Assembly of "An Act in Amendment of and In Addition to Title 11, Chapter 34 of the General Laws of the State of Rhode Island Entitled, 'Prostitution and Lewdness'."

COUNCILMAN FLYNN moves the Resolution be Amended by Deleting in Section 11-34-8, fourth line, the word "reportedly" and adding in lieu thereof "repeatedly"; add the words "in all such cases" in line five following the words "motor vehicles".

This motion is seconded by **COUNCILMAN ADDISON**.

Resolved, That the City Solicitor is requested to cause to be introduced and to urge passage at the 1980 Session of the General Assembly of an Act in amendment of and in addition to Title 11, Chapter 34, of the General Laws of the State of

Rhode Island, entitled "Prostitution and Lewdness", by adding the following:

"Section 11-34-8. It shall be unlawful for any person or persons to stand or wander about any public place, public highway, and/or Street, and repeatedly attempt to engage passerby in conversation, or repeatedly stop or attempt to stop motor vehicles in all such cases for the purpose of prostitution or of patronizing a prostitute, said person or persons shall be guilty of loitering in a public place, and shall be liable to be imprisoned up to one (1) year or fined up to five hundred dollars (\$500.00) or both.

This Act shall take effect upon its passage."

The Resolution is thereupon Read and Passed as Amended, on motion of **COUNCILMAN ADDISON**, seconded by **COUNCILMAN EASTON**.

The motion for Passage as Amended is Sustained.

COUNCILMAN FLYNN and COUNCILMAN DILLON (By Request):

Resolution Requesting the Supervisor of Environmental Control to Cause Those Vacant Lots Located along Dexter Street at Its Intersection with Mawney Street to be Cleaned of All Debris.

Resolved, That the Supervisor of Environmental Control is requested to cause those vacant lots located along Dexter Street, at its intersection with Mawney Street, to be Cleaned of all debris.

Read and Passed, on motion of COUNCILMAN ADDISON, seconded by COUNCILMAN GLAVIN.
