RELATING TO THE SOLEMNIZATION OF MARRIAGES

It is enacted by the General Assembly as follows:

SECTION 1. Section 15-3-5 of the General Laws in chapter 15-3 entitled "Solemnization of Marriages" is hereby amended as follows:

15-3-5. Officials empowered to join persons in marriage. - Every ordained clergy or elder in good standing, every justice of the supreme court or superior or family court, or district court, every associate justice, the clerk of the supreme court and every clerk of a superior court, the family court, and of a district court, and every former justice of said courts and former chief clerk of the district court and every chief-elected official of any municipality incorporated in the state may join persons in marriage in any town in this state; and every justice and every former justice of the municipal court of the City of Providence and of the municipal court of the City of Pawtucket may join persons in marriage in any city or town in this state and wardens of the Town of New Shoreham may join persons in marriage in said town.

SECTION 2. This act shall take effect upon passage.
