

# RESOLUTION OF THE CITY COUNCIL

*No.*

*Approved*

WHEREAS, the cost of operation of City of Providence in almost all municipal departments has increased sharply, and

WHEREAS, the population of Providence has declined from over 250,000 to approximately 170,000 or about a 25 per cent decline, and

WHEREAS, the City's free reserves have been almost exhausted and new tax increases have been predicted are likely,

WHEREAS, the cost of City Government has been increasing sharply and faster than our tax base and cost of living increases, and

WHEREAS, an extensive and exhaustive study of the cost of operations of the various departments of the City should first be made, with a view toward reducing unnecessary cost and expenses of the City before determining the need for any such further increase in taxes,

NOW THEREFORE, BE IT RESOLVED, That the President of the City Council be and he is hereby authorized to appoint a Special Committee of the Council, to consist of five (5) members, one of whom shall be the Chairman of the Finance Committee of the Council, and not less than two of whom shall be from the opposite political party of the Mayor, to make a comprehensive study, investigation, and report of the financial structure of the City government with a view to examining also the costs, expenditures and operations of the various departments of the City government. The Committee will take into consideration but is not limited to:

1. The costs and operation of all phases of municipal government;

2. Possible consolidation, reduction and increased efficiency of departments and services;
3. The basis upon which personnel is selected, the activities of personnel and the performance upon a time basis of their work;
4. A study of existing statutes relating to the assessment and collection of taxes and the necessity and nature of a revision of the tax system;
5. Possible inter City compacts and combining and pooling of facilities to economize, and
6. Improvement of purchase and sale procedures and use of governmental purchasing procedure.

In the performance of its duties, the said Committee shall be authorized and empowered to undertake any studies, inquiries, surveys, analysis it may deem relevant, and is further authorized and empowered as are committees of the Council in such instances under the provisions of Sections 30 and 31 of Chapter II of the Charter of the City of Providence.

The Committee may engage and employ such government experts, accountants and qualified advisers as may be deemed necessary and may request such persons to attend its meetings as well as carry out surveys and other tasks of the Committee.

The Committee shall report on or before June 30, 1972, to the Mayor and the City Council with its recommendations, including those changes in law or procedure necessary to implement said recommendations and the members of said Committee shall receive no compensation for their services, but shall be allowed their actual and necessary expenses in the performance of their duties, including the cost of such clerical and other assistants as they may deem necessary, the funds to cover such expenses being hereby appropriated from the Reserve for Extraordinary Expenses Account.

ANNUAL REPORT: COMMUNICATIONS DEPARTMENT--1971

PERSONNEL:

Police Control Center:

As of this date, there are five (5) Patrolmen, two (2) Sergeants and one (1) Lieutenant who are uniformed members of the Police Department; all other personnel are civilians. Since this Department took control of the Police Control Center, seventeen (17) policemen either have retired or have been reassigned from the Control Room and have been replaced with civilian help. Civilian personnel that were assigned to the Control Center but detailed to other divisions, have been returned to the Control Room. Nine (9) of the personnel of the Control Room are new employees obtained through the Federal Government EEA of 1971.

Fire Alarm--Bureau of Operations and Control:

For the first time in the history of the Fire Alarm Division, civilian employees have been assigned to the Control Room. At present there are seven (7) persons who were obtained through the EEA of 1971. These civilians have replaced firefighters that have

retired or that have been reassigned. Presently there are five (5) positions for civilian personnel that are unfilled. These will be filled when it is felt that the new personnel already hired are trained, or when any additional firefighters are reassigned.

Maintenance Help:

Four (4) Fire Alarm Technicians were hired under the EEA and were assigned to the Communications Department Garage (Fire Alarm); these openings were also created by retirement or reassignment of firefighters.,

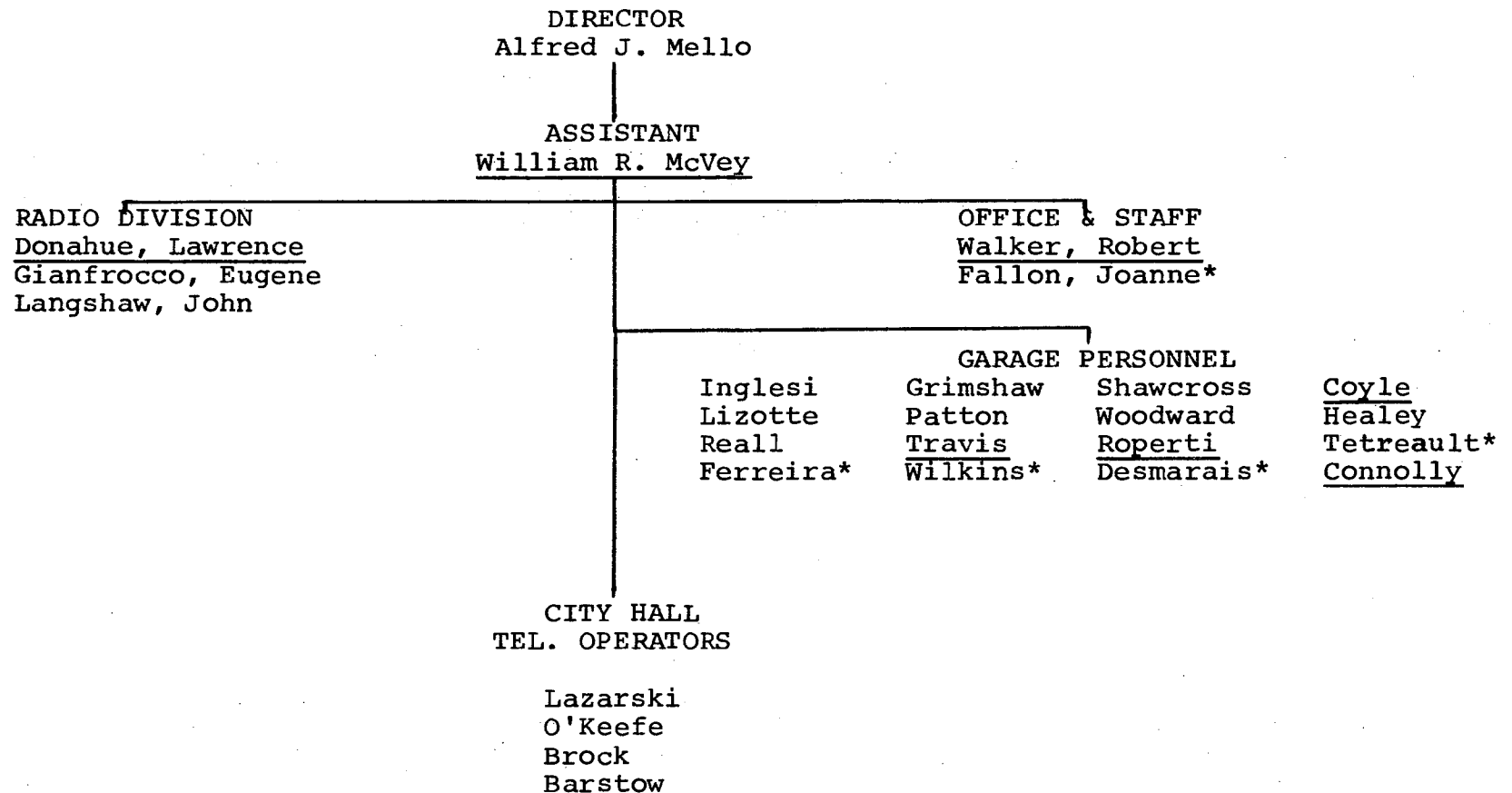
At the present time all personnel hired under this act are performing well, and no major problems have been encountered. The four technicians under the EEA Program, along with all existing personnel of the Communications Department (outside plant), have received one (1) week of concentrated schooling in respect to their line of work. This school was under the direction of William R. McVey, Assistant Superintendent of Fire Alarm, and included methods and techniques for performance of their duties along with safety precautions that should be taken.

Mr. McVey was assisted by films obtained from the Narragansett Electric Company and the Telephone Companies. Class room work was done at the Fire

Department Division of Training and practical work  
was performed at the Melrose Street Plant, Pole  
Yard of the Electric Company.

PUBLIC TELEPHONE SYSTEM:

Since the beginning of the formation of the Communications Department in March of 1971, two surveys were conducted in conjunction with personnel of the Telephone Company; one at the Police Department and the other at City Hall. The results of these surveys are as follows:

Police:

As a result of the inventory approximately twenty-five (25) telephones or lines were removed. These were units that were no longer in use but had never been officially discontinued. Restrictions have been put on all long distance calls by the installation of Toll Diversion. In addition, records of all long distance calls are being kept which has resulted in fewer such calls being made.

Due to renovations being made at the Police Headquarters Building, considerable moving of telephone equipment was made necessary. At the same time the system was upgraded where needed. The changes are a result of the inventory which has also resulted in considerable savings (up to as much as \$1400.00 per month).

City Hall:

As a result of the inventory of City Hall telephones and equipment, nineteen (19) telephones and lines were removed from the building. The telephone system in the Tax Assessors Office and the Probate Court were found to be antiquated and inadequate for the amount of business transacted. These two systems were completely updated and other minor improvements were made to the City Hall telephone system to bring it up to today's standards. The removal of the nineteen (19) lines mentioned above will offset the cost of the equipment added. So although the monthly charges will remain about the same, we are receiving better service as a result of the improvements in the system.

Police Call Box System:

Under a Federal Grant the City has applied for funds to update our outmoded Police Call Box System. In order to renovate the old system, it would have cost the City approximately \$40,000.00 for new central office equipment. Under the new system we have done away with most of the Police Call Boxes and are now utilizing twenty-seven (27) dial type telephones located throughout the City at strategic locations. These are housed in the

old Police Boxes and enable the user to contact any extension on the Police Switchboard. This was made possible because of the widespread use of portable radios enabling the patrolman to call in directly without having to go to the Police Call Box. This system uses City owned cables and is phased into the Bell System at Police Headquarters.

FIRE ALARM MAINTENANCE:

As of December 31, 1971 there are 375 Private Fire Alarm Boxes and 695 Public Fire Alarm Boxes in service making a total of 1070; this is an increase over last year of 18 new boxes. At the present time there are approximately 35 more boxes in the process of being put in service; these are mostly private boxes. Private boxes are being recommended by Insurance Companies to their Policy Holders in order that early detection of fire is made and relayed to the Fire Alarm Office, thereby cutting cost figures in cases of fire damage.

During the course of the year a major project of this Department was the replacement of our main feeder cable for the upper East Side and parts



of the north end. This is our number one cable from Fire Alarm, and it is a fifty (50) pair cable that was damaged by the 1954 hurricane. It was replaced from Washington Street and Dorrance Street to North Main Street and Amos Street and will be continued to its termination on Rochambeau Avenue under this year's planned cable replacement program.

Approximately 50,000 feet of aerial wire was replaced, and all of our aerial Fire Alarm Circuits have been cleared of branches and other interference. This is part of this department's regular maintenance program of the system. At no time throughout the year was the Fire Alarm System inoperative to the citizens of the City.

In addition to the radio units, the men of the radio division are also responsible for approximately twelve (12) intercom systems, two (2)

multi-channel tape recorders (Police and Fire),  
Vocalarm systems to each Fire Station, and main-  
tenance of test equipment.

All radio units were checked to meet the  
requirements of the F. C. C., and repairs made  
when necessary to assure compliance.

Copies of Annual Reports of the Chief Dis-  
patcher at the Fire Alarm Bureau of Operations  
and Control and the Chief Dispatcher at the Police  
Control Center are also attached.

Dear Mr. Mello:

The principal duty of the Bureau of Operations and Control is the accurate interpretation of all emergency calls and retransmission to the proper apparatus of the Fire Department.

Attached is a breakdown of all types of alarms transmitted during 1971 compared with those received during the previous year.

As you will notice the total numbers of alarms transmitted during 1971 has increased in all categories with the exception of Rescue Alarms. The largest increase this year has been in the number of Box Alarms. As in the past the majority of our Box Alarms have been false. Rescue calls have been reduced this year. I feel this is due to the continued screening of all calls by the BOC, and also the fact that the Rescues can only transport to the hospital within the zone that the emergency occurs.

Lockouts have increased again this year. I feel this trend will continue until we apply a service charge for this type of service, especially in the case of repeat calls to the same address.



In November seven new employees were assigned to this office under the Emergency Employment Act of 1971. Training these members will take somewhat longer than the training of members of the Fire Department. When firefighters are assigned to this unit they know from experience the locations of the different apparatus, the capabilities of each, locations of most of the city streets, the different types of alarms and also a working knowledge of the fire service. In the case of new civilian personnel, all of this must be learned before they can be considered proficient.

This office is responsible for the keeping of all records of all alarms transmitted. We also record all tests by the Communications Department, insurance companies, and other authorized testing agents. This record keeping requires the services of one man to receive and record these tests.

In closing I would like to thank the member of BOC for having handled all calls in a most expeditious manner, many times under adverse conditions, and also for their continued dedication to their work, particularly during major emergencies.

The following report is a compilation of the work load for the Radio Control Center at the Providence Police Headquarters for the year ending December 31, 1971.

Cars dispatched to complaints for which C. C. R. numbers were assigned, such as assaults, robberies, burglaries, house-breaks, alarms, and felonies or other serious complaints demanding the assignment of such numbers: 77,458

Cars dispatched to complaints for which no C. C. R. numbers were assigned, such as the congregation of "gangs" on corners, loud music, and other calls that were not felonies or serious enough to warrant the assignment of a C. C. R. number: 57,600

Teletype messages sent on the teletype machine: 14,500

Nine civilian employees were hired under the  
 Emergency Employment Act of 1971 and were

 control center operators. As with all  
 new civilian employees, much more time will

## FUTURE PLANS OF THE COMMUNICATIONS DEPARTMENT--1972

1. School Department Public Telephone System

As per your request, a complete survey is being made of the School Department Telephone System. This survey is being conducted by Lieutenant Robert Walker of this department and a representative of the Telephone Company. At this time with just a few areas of the system that have been surveyed and evaluated, it is my opinion that considerable savings will be realized by the School Department as my recommendations are put into effect.

2. Proposed Fee For Private Fire Alarm Boxes

A considerable amount of time has been spent on research and inquiring what other cities are doing in regard to "fee" charging for Fire Alarm Service in private buildings. It is my hope that before July 1, 1972, I will request of you the necessary ordinances to implement such a plan. I feel that as much as \$40,000.00 could be realized annually from this fee.



3. Improvements Made On The Police Switchboard

A request has been made by this department to the New England Telephone Company to replace the Telephone Switchboard at Police Headquarters and associated switching equipment. This will all be changed by May of 1972 with no additional charges.

The reason for this request is to speed up the police telephone system by the use of a cordless board and eliminate breakdowns that we now encounter because of the vintage of the switching equipment currently in use.

4. Changes At Department of Public Buildings

Presently a survey is being conducted as to the advisability of eliminating the need of a switchboard at the Department of Public Buildings. It is my hope to eliminate this board when a new switchboard is installed in City Hall. If this is possible, I feel strongly that one (1), possibly two (2), operator's positions could be eliminated without impairing the efficiency of both City Hall and the Public Buildings Departments. Also the monthly charges would be considerably less.
