



A BIOGRAPHY OF SCOTT WOLF

For more than three decades, Scott Wolf has transformed opinion and policy research into effective communication and legislative strategies for progressive policy organizations, media outlets, elected officials and political candidates. Wolf has substantial experience leading public policy organizations, including his current position as Executive Director of Grow Smart Rhode Island. From 1995 through early 1999, Wolf served as Executive Director of The '98 Project, a national issue education organization sponsored by labor, senior, environmental and social service organizations, and focused on Congress's agenda and ballot initiatives. He also served as manager of the 1994 Ron Sims for U.S. Senate campaign, directed the Rhode Island Governor's Office of Housing, Energy and Intergovernmental Relations and was President of Scott Wolf and Associates, a political and public policy consulting firm. The firm's clients included Americans for the Environment, NBC News, the Shreveport, LA Downtown Development Authority and U.S. Senators Tim Wirth and Gary Hart.

As Grow Smart Rhode Island's Executive Director, Wolf oversees all Grow Smart operations, including administration, research, coalition building, public education, media outreach, fundraising, and issue advocacy. Grow Smart Rhode Island is a broad coalition of community leaders committed to well planned growth that is environmentally responsible, socially equitable, and financially efficient. The Grow Smart coalition includes business and religious leaders, environmentalists, builders, realtors, historic preservationists, urban revitalization advocates, and the presidents of several major colleges and universities. Since Wolf joined Grow Smart in March of 1999, the organization has received awards from EPA's Region 1 Office, the advocacy group Preserve Rhode Island, the Providence Preservation Society, The Environmental Business Council of New England, the Rhode Island Chapter of the American Planning Association and Rhode Island Housing.

A veteran community and political activist, Wolf ran for Congress in 1988 and 1990 from his native state of Rhode Island, strongly challenging two incumbent congressmen. As a senior staffer for Rhode Island Governor Bruce Sundlun from 1991 to 1994, Wolf promoted education reform initiatives, ran the state's heating assistance and principal energy conservation programs, and coordinated state government's relations with local communities and the federal government. In his intergovernmental relations' role, Wolf oversaw the state's takeover of a local school system, successfully advocated a new state general revenue sharing program for municipalities, and secured federal health care waivers and extra Medicaid funding for Rhode Island.


Earlier in his career, Wolf played a substantial role in the Democratic Party's national research and communications efforts. He served four years as a research consultant to the Democratic Senatorial Campaign Committee, where he developed a strategy to counter the "New Right" movement. Before joining the DSCC, Wolf was the first Research Director for the Carter-Mondale Reelection Committee, a post he assumed after two years as the Democratic National Committee's Director of Political Research. At the DNC, Wolf was part of a strategy team promoting Carter Administration initiatives such as the nation's first Energy Act. He also trained hundreds of individuals in campaign and research skills, and analyzed public opinion trends for Democratic elected officials nationwide.

A 1975 Phi Beta Kappa graduate of Brown University, Wolf began his career as a public opinion analyst for William R. Hamilton and Staff and Peter D. Hart Research Associates. For many years, he has also worked with the media in roles ranging from political commentator for a Providence television station to adviser for a 1987 PBS series "Ethics in America".

Elected as a 1992 Democratic National Convention delegate for Bill Clinton, Wolf's other community activities have included board positions with a local hospital, an adult day care center, the Providence Zoning Board of Review, a literacy training organization, and a Jewish social welfare agency. Wolf resides in Providence with his wife, Joyce Krabach, a former school principal and award winning early childhood teacher.




