

Councilman Nicholas J. Narducci as Deputy Majority Leader.


In addition, the attending members voted unanimously to support:



7. Motion made by Nicholas J. Narducci for the Democratic Caucus to support the election of Councilman Terrence Hassett as Council President Pro Tempore for the 2011 – 2015 term. Second by Seth Yurdin. Nomination approved unanimously.

There being no further business, the meeting was ADJOURNED.






