Be it ordained by the City of Providence:

SECTION 1. Chapter 27 of the Code of Ordinances of the City of Providence, Entitled: "The City of Providence Zoning Ordinance", Approved November 24, 2014, As Amended, is hereby further amended by changing the Zoning text of Section 1204, "Use Definitions" to read "A day care center and/or preschool may be included as part of an Educational Facility - Primary or Secondary as an ancillary use".

SECTION 2. This Ordinance shall take effect upon passage.



Changing the text of Section 1204, "Use Definitions" from the following:


"Educational Facility – Primary or Secondary. A public, private, or parochial facility that offers instruction at the elementary, junior high, and/or high school levels."
