**COUNCILMAN SEGAL and COUNCILMAN LUNA:**

Resolution Opposing the Federal Communication Commission's weakening of certain restrictions on media ownership.

*Whereas*, The Federal Communications Commission recently voted to change media ownership regulations so as to increase the number of television stations that a single company may own in a single market; allow a single company to own both a television station and a newspaper in the same market; and increase the percentage of the nation's population that may be reached by television stations owned by a single company; and

*Whereas*, Limits on media ownership were put in place in order to protect the public's ability to choose from a plethora of media sources, and to facilitate every citizen's access to an abundance of viewpoints; and

*Whereas*, The recent regulatory changes allow for increased consolidation of the ownership of media outlets; and

*Whereas*, Similar deregulation mandated by the Federal Telecommunications Act of 1996 has contributed to a decline in the number of radio-station owners nation-wide, by the order of 30 percent over the last seven years; and

*Whereas*, Access to diverse sources of information and dissenting voices is in the public interest, while increased consolidation is not; and

*Whereas*, Public input on this matter has been restricted, and FCC Chairman Michael Powell has attended only two of the 13 public meetings at which the FCC has taken comment relative to it; and

*Whereas*, The overwhelming majority of comments filed with the FCC about the rule changes is in opposition to said changes; and

*Whereas*, Members of Congress have demanded that the FCC share with them the research used to justify the regulatory changes, but the FCC has refused to do so.

*Now, Therefore, Be It Resolved*, That the City Council of the City of Providence, Rhode Island, hereby opposes the aforementioned recent changes in media ownership rules and, hereby urges the passage of bills H.R. 2052 and S. 1046, which would mandate that stations owned by a single company reach no more than 35% of the population of the United States and, hereby urges the Rhode Island Delegation to the United States Senate and House of Representatives to do all in its power to reverse the aforementioned regulatory changes.

*Now, Therefore, Be It Further Resolved*, That the City Clerk shall forward copies of this resolution to President Bush, Senators Reed and Chaffee, and Representatives Kennedy and Langevin.

Resolution Relative to the Providence Redevelopment Agency Parcel 12 Project.

*Whereas*, The City has requested that the Providence Redevelopment Agency (the "Agency") purchase Parcel 12 from the City for certain predevelopment work prior to selling the property to a developer; and

*Whereas*, The Agency intends to finance its purchase by a lease back to the City; and

*Whereas*, As required by Sections 45-32-5(1)(k) and 45-32-48 of the General Laws of Rhode Island, the Agency has submitted a Report to the City Council dated May 8, 2003 (the

"Report") concerning the proposed Lease between the City and the Agency of Parcel 12; and

*Whereas*, As described in the Report, the Providence Redevelopment Agency will retain title to Parcel 12 until payment in full of the Agency's obligations issued to finance the purchase of Parcel 12 from the City (the "Obligations"); and

*Whereas*, In connection with the issuance of the Agency's Obligations, under applicable securities laws and regulations, the City will be required to provide continuing disclosure regarding the City;

*Now, Therefore, Be It Resolved, That:*

1. The City Council hereby approves the transfer of all right, title and interest of the City to Parcel 12 to the Agency.

2. The City Council hereby authorizes the Mayor to enter into the Lease as described in the Report of the Agency, and the Mayor is authorized to take any and all action and to execute, file, and deliver the Lease and any and all agreements, notes, and other documents in such form as he may deem necessary or desirable to implement the Agency's financing of the Parcel 12 Project as described in the Report.

3. The City Council, pursuant to Section 45-32-5(3) of the General Laws of Rhode Island, authorizes the Agency to retain title to Parcel 12 for twenty (20) years or until the Obligations are retired.

4. This Resolution is an affirmative action of the City towards the issuance of the Obligations in accordance with the purposes of the laws of the State. This Resolution constitutes the City's declaration of official intent, pursuant to Treasury Regulation Section 1.150-2, to reimburse the City's General Fund for certain capital expenditures for the Project paid on or after the date which is sixty (60) days prior to the date of this Resolution but prior to the issuance of the Obligations, or otherwise as permitted by such regulation. Amounts to be reimbursed shall be reimbursed not later than eighteen months after (a) the date on which the expenditure is paid or (b) the date the project is placed in service or abandoned, but in no event more than three (3) years after the date the expenditure is paid.

5. The City's Director of Finance is authorized to execute and deliver a continuing

disclosure certificate in connection with the Obligations issued by or on behalf of the Agency, in such form as shall be deemed advisable by the City's Director of Finance. The City hereby covenants and agrees that it will comply with and carry out all of the provisions of the continuing disclosure certificate, as it may be amended from time to time. Notwithstanding any other provisions of this Resolution or the Obligations, failure of the City to comply with the continuing disclosure certificate shall not be considered an event of default; however, any certificate holder may take such actions as may be necessary and appropriate, including seeking mandate or specific performance by court order, to cause the City to comply with its obligations under this Resolution and under the continuing disclosure certificate.

6. This Resolution shall take effect on passage.
