Gentlemen:

Reference is made to Resolution of the City Council No. 268, dated 17 April 1964, requesting a determination of need to raise the height of the pedestrian railing on the Hawkins Street Bridge No. 429 over Rhode Island Route No. 146.

The height of this rail is approximately 36" above sidewalk level. This is above the minimum standards as determined by the "Standard Specifications for Highway Bridges" by the American Association of State Highway Officials and is the same height as is furnished on all similar bridges elsewhere in the State.

In 1958 some people in the area became concerned about the possibility of youngsters falling through the space between the rails and the State installed additional wire mesh to back up the railing. This is considered sufficient protection for very young children and there is no practical height of railing which can be considered to be entirely climb-proof for older children.

There is no practicable way of extending the present railing while maintaining good appearance and no higher rail is commercially available, so that to raise the height would entail replacing the entire rail with a specially manufactured railing which would put the State to considerable expense.

Because this railing provides the same degree of safety as those provided in all other places in the State and because the railing height provided is considered to be adequate by accepted standards, the State does not feel that raising the height of the railing would be justified.
