CHAPTER 1984-31

No. 321 **AN ORDINANCE** TO AUTHORIZE THE ISSUANCE OF A \$1,805,000 REFUNDING BOND, AS AMENDED.

Approved May 24, 1984

Be it ordained by the City of Providence:

SECTION 1. The sum of \$1,805,000 shall be borrowed for the purpose of refunding the \$1,805,000 Public Improvement Bond dated December 15, 1983, payable June 15, 1984. The amounts to be refunded are \$160,000 borrowed under Chapter 8 of the Public Laws of 1967; Chapter 181 of the Public Laws of 1971, and Ordinance Number 1982-65; \$200,000 under Chapter 51 of the Public Laws of 1972 and Ordinance Number 1982-67; and \$1,445,000 under Chapter 90 of the Public Laws of 1974 and Ordinance Number 1982-66. The City Treasurer, with the approval of the Mayor and the Committee on Finance, is authorized to issue a \$1,805,000 refunding bond dated June 15, 1984, payable June 14, 1985, pursuant to Section 45-12-5.2 of the General Laws, and to determine the interest rate and other terms and details of the bond.

SECTION 2. This Ordinance shall take effect upon its Passage.
