Duties: Assist the Chief of Capitol Police in coordinating and supervising the operations of the capitol police force and doing related work as required. Supervise and review the work of police officers and other security personnel. Review and summarize the reports of

subordinates and take appropriate actions based on these reports. Make recommendations on a variety of matters; such as the acquisition of security systems and equipment for the operation of building security. Coordinate the unit's efforts with other law enforcement agencies. Assist in maintaining proper records and preparing various reports. Assist in enforcing the rules and regulations of the force by reviewing reports and conducting inspections. Assist in a training program to provide information on law enforcement policies and laws. Assist in monitoring the communication system. In the absence of the Chief, to supervise and administer the Capitol Police Force.

Position: (June 1978 - October 1979): Administrator, Consumer Protection

Duties: Supervised approximately 35 investigators, secretaries and interns. Sponsor of the Rhode Island Internship Program.
