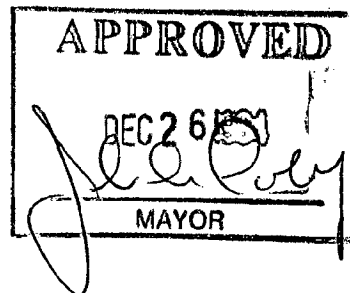
Approved December 26, 1984

Dear Councilwoman Brassil:

We are the operators of Barnsider's Mile and A Quarter, which is located in your district. Over the past year, we have worked with the Providence Police and the Mayor's Office in an effort to remedy the constant problem of vandalism and car theft at Mile and A Quarter.

I am enclosing a letter that we sent to Mayor Joseph Paolino to provide you with some background information. The Mayor has been very helpful in bringing this problem to resolution. We have also been in touch with Sergeant Aubin of the Providence Police, who is endeavoring to secure mounted and canine patrols; Major Zielinski is hopefully committing these patrols to the immediate area. However, it is the consensus that the installation of sodium vapor or mercury street lights in the immediate area would substantially deter the current crime wave.

I believe it would greatly benefit the citizens of Providence, the immediate residents of the area, and certainly ourselves if you would present our case for installation of street lights to the City Council. Apparently, the recommendation must be issued by the Council before Narragansett Electric will install these lights. It can be noted that many of the newer, higher aluminum lights are substantially less expensive to operate as well as providing considerably more brilliance to any area. I urge your support and action on this much needed improvement for this area of Providence.

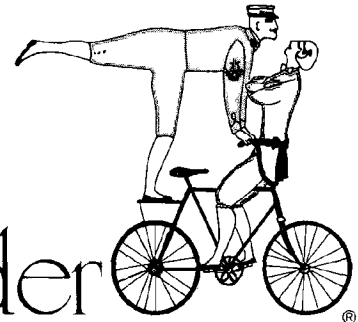
