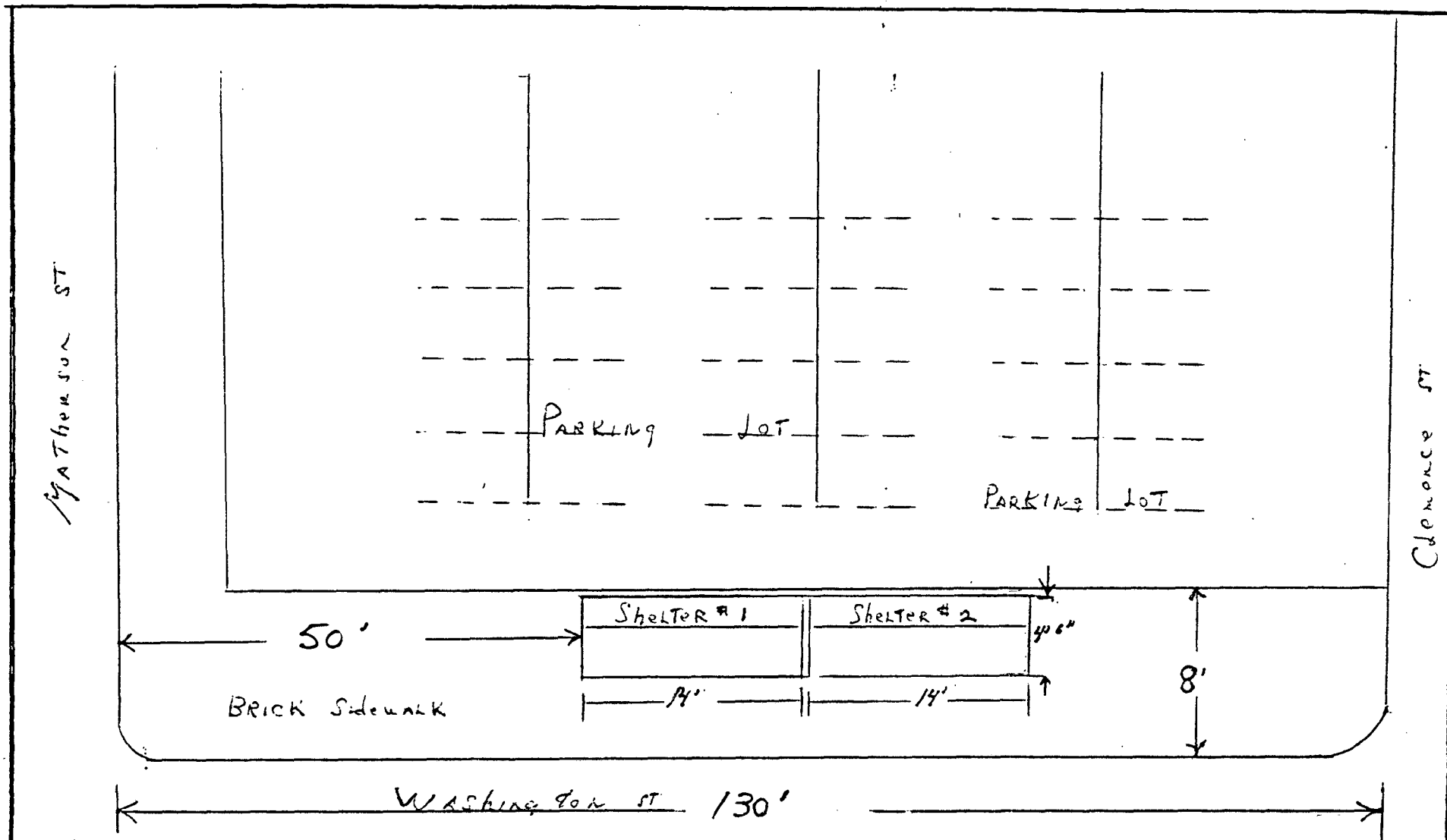

Senior center clients lobby for bus shelter

PROVIDENCE — A group of Gray Panthers marched from the Westminster Senior Center to City Hall yesterday seeking to hasten the installation of a bus shelter at Washington and Mathewson Streets.

"Even though the weather's nice today, next week there could be a very bad storm," said John Kline, who headed the group of nine protesters.

"Then an elderly or handicapped person could slip and hurt themselves," he said.

Last year the city asked RIPTA to move the bus stop from the other corner, where riders could seek shelter in doorways, Kline said. The new location next to a parking lot provides no shelter from the elements, he said.

William Trevitt, general manager of the Rhode Island Public Transit Authority, indicated his support two months ago and the Providence Journal Co., which owns the

adjacent parking lot, also favors erecting the shelter on public land, Kline said, but the matter seems snagged in the City Council.

Gunter Vukic, staff coordinator for Mayor Vincent A. Cianci Jr., and Wilbert Fleming, a mayoral aide, reassured the visitors.

"We're all going in exactly the same direction," Vukic said.

The council had to check to see that the proposed shelter would not block the passage of pedestrians or obstruct the view of cars turning at that corner, Vukic said.

He and Fleming will see that the issue is on the City Council agenda for the meeting Thursday, Vukic said, and will gather any material needed to answer potential questions so the matter can be decided immediately.

Trevitt, contacted later, said the city has been cooperative and that the shelter can be installed within a few days once the city grants permission.
