No. 345 **AN ORDINANCE** IN AMENDMENT OF CHAPTER 544 OF THE ORDINANCES OF THE CITY OF PROVIDENCE APPROVED SEPTEMBER 21, 1951 CHANGING FROM AN R-3 GENERAL RESIDENTIAL ZONE TO AN M-1 GENERAL INDUSTRIAL ZONE, LOTS 100, 101, 129 and 130 AS SET OUT AND DELINEATED ON CITY ASSESSOR'S PLAT 37; SAID LOTS BEING LOCATED ON THE NORTHEASTERLY and SOUTHEASTERLY CORNERS OF ATWOOD and DORA STREETS AND DESIGNATED AS 95-99 ATWOOD STREET and 103-105 ATWOOD STREET.

Be it ordained by the City of Providence:

Section 1. Chapter 544 of the Ordinances of the City of Providence, approved September 21, 1951, as heretofore amended, is hereby further amended by changing from an R-3 General Residential Zone to an M-1 General Industrial Zone, Lots 100, ^{129 and 130 DEW} and 101, as set out and delineated on City Assessor's Plat 37; said lots being located on the northeasterly and southeasterly corners of Atwood Street and Dora Street and designated as 95-99 and 103-105 Atwood Street is amended to read as follows:

"The zoning map accompanying and made a part of Chapter 544 approved September 21, 1951, as heretofore amended and entitled "An Ordinance zoning the City of Providence and establishing use, height and area regulations" is hereby further amended by changing from an R-3 General Residential Zone to an M-1 General Industrial Zone, lots 100, 101, 129 and 130 as set out and delineated on City Assessor's Plat 37; said lots being located on the northeasterly and southeasterly corners of Atwood Street and Dora Street and designated as 95-99 and 103-105 Atwood Street, bounded and described as follows:

"Beginning at the northeasterly corner of Atwood Street and Dora Street; thence northerly along the easterly line of Atwood Street to the northwesterly corner of Lot 100 on Assessor's Plat 37; thence easterly along the southerly line of Lot 99 to the northeasterly corner of Lot 100; thence southerly along the westerly line of Lot 44 to the northerly line of Dora Street and the southeasterly corner of Lot 101; thence westerly along the northerly line of Dora Street to the northeasterly corner of Atwood Street and Dora Street and the point and place of beginning.

Also beginning at the southeasterly corner of Atwood Street and Dora Street and running easterly along the southerly line of Dora Street to the northeasterly corner of Lot 130 on Assessor's Plat 37; thence southerly along the westerly line of Lot 44 to the southeasterly corner of Lot 129; thence westerly along the northerly line of Lot 74 to the easterly line of Atwood Street and the southwesterly corner of Lot 129; thence northerly along the easterly line of Atwood Street to the southeasterly corner of Atwood and Dora Street and the point and place of beginning.

Sec. 2. This Ordinance shall take effect upon its passage and Chapter 1109 approved April 5, 1957 is hereby rescinded.

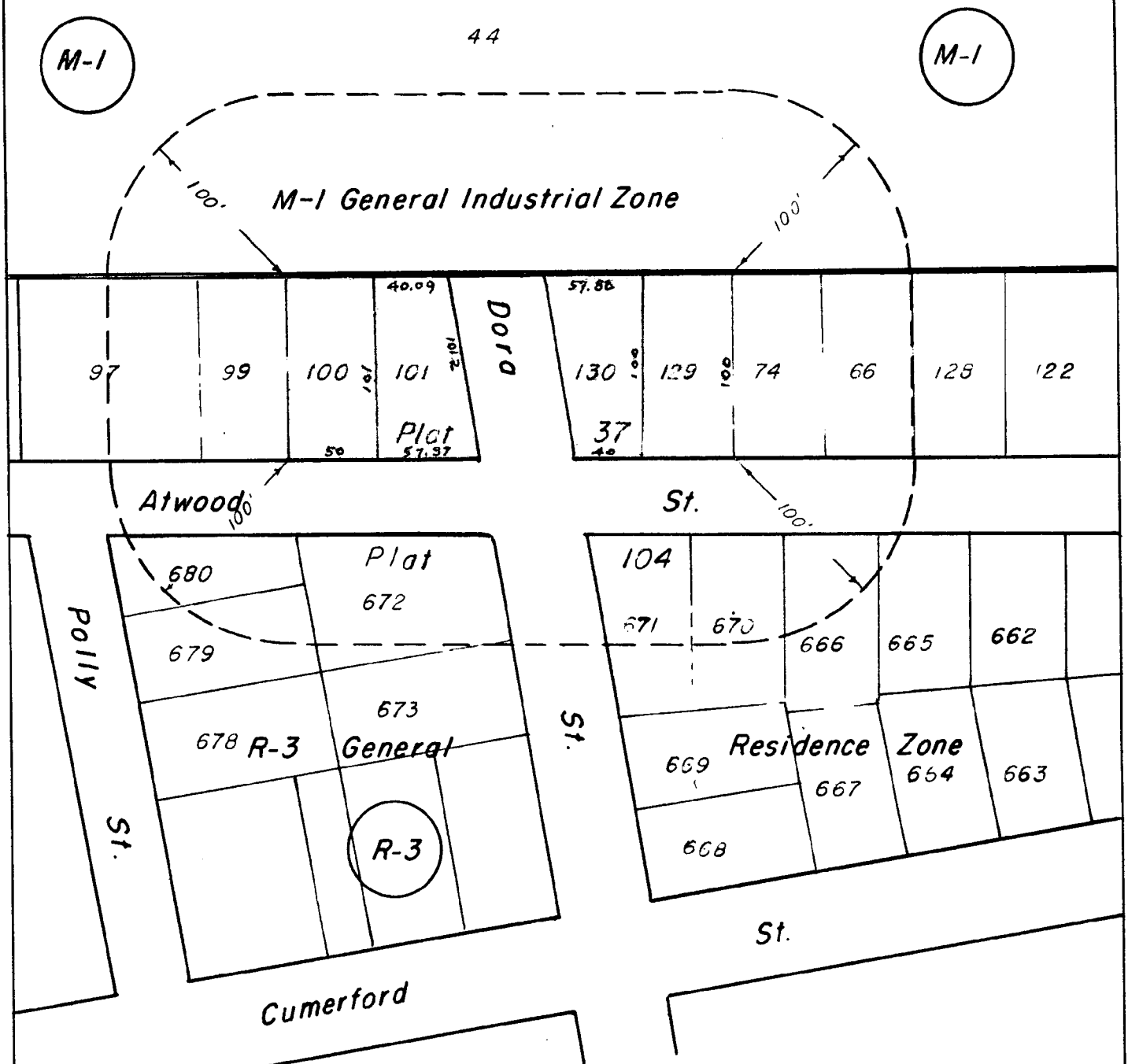
