## **ORDINANCE(S) SECOND READING**

**The Following Ordinances were in City Council June 6, 2024, Read and Passed the First Time and are Severally Returned for Passage the Second Time:**

### **COUNCILMEN GONCALVES AND VARGAS**

An Ordinance in Amendment of Chapter 2004-36, No. 348, Approved August 13, 2004, Entitled: "An Ordinance Granting the Downtown Providence Management District Authorization to operate as a Business Improvement District".

***WHEREAS***, The Providence City Council, pursuant to R.I.G.L. Title 45, Chapter 59, has the authority to establish Business Improvement Districts; and

***WHEREAS***, The Providence City Council has adopted Chapter 21, Article XIII, to provide for the creation and functioning of Business Improvement Districts; and

***WHEREAS***, Petitions bearing the signatures of the owners of more than 60% (by assessed valuation) of the real property within a proposed Downtown Providence Management District have been submitted to the City Clerk; and

***WHEREAS***, The Downtown Providence Management District Authority seeks to insure the continued vitality of the business district in downtown Providence, and to retain and attract new businesses and investments; and

***WHEREAS***, Neither the state law nor this Ordinance contemplate any erosion of the City's powers and authority; and

***WHEREAS***, The petitioners agree that the City's jurisdiction to issue permits and approvals is retained, and that none of the purposes or powers included within the grant of authority contained herein shall be exercised to limit the City's jurisdiction; and

***WHEREAS***, The Providence City Council desires to set forth its expectations regarding the relationship between the Downtown Providence Management Authority and the Council; and

***WHEREAS***, The petitioners have expressed a desire to cooperate in the implementation of the Downtown Providence Management District, so as to guarantee that the City will be held harmless and will be made whole for any claims, suits, or uncollectable accounts arising from actions of the Downtown Management District Authority; and

***WHEREAS***, The Providence City Council finds that it is in the interest of the residents of the City of Providence to Grant the petition to establish the Downtown Providence Management District and to authorize the Downtown Providence Management District Authority to oversee the operations of the Downtown Providence Management District;

Now, therefore, it is enacted as follows,

The Providence City Council finds that:

1. The petition, constituting in the aggregate sixty percent (60%) of the aggregate assessed valuation of all real property not exempt from taxation by law, seeks to establish as the Downtown Providence Management District all property within the boundaries of Memorial Boulevard on the north with the addition of Citizens Plaza parcel (A.P. 19 Lot 10), to the Providence River on the east, to Interstate Route 195 on the south, and to Interstate Route 95 and Franklin Street on the west; separated into three sub districts: Zone One (1), Zone Two (2), and Zone Three (3) [see Exhibit A, attached]; and

2. A majority of the area of the land located within the proposed district is devoted to commercial and retail uses. Zone One (1) is the core of downtown and includes the area commonly referred to as Downcity, plus areas to the south, east and north. This area of approximately forty-nine (49) blocks has the highest need for security and maintenance services as well as a retail development program. Zone One is formed by a boundary that starts at the intersection of Kennedy Plaza and Dorrance Street and heads southeast along Dorrance Street to the intersection of Dyer Street, heads south on Dyer Street to the I-195 right of way, follows the I-195 right of way to the intersection with Chestnut Street, heads northwest along Chestnut Street to the intersection of Broad Street, heads southwest on Broad Street to the intersection of Green Street, heads northwest on Green Street to the intersection of Sabin Street, heads northeast on Sabin Street to Exchange Terrace, follows Exchange Terrace to the intersection of Kennedy Plaza, heads southwest on Kennedy Plaza to the starting point at the intersection of Kennedy Plaza and Dorrance Street. Zone Two is the area surrounding Zone One and includes the Financial District, Union Station complex, Convention Center, Regency Plaza, Cathedral Square, and Weybosset Hill areas of downtown. This area of approximately thirty-four (34) blocks has a less intense need for security, maintenance and retail development services. Zone Three is the area immediately north of Zone Two, and encompasses the area known as the state house grounds ending at Smith Street. This zone includes the, Veterans Memorial Auditorium, Station Park and Waterplace Park. This area has a less intense need for security, maintenance and retail development services.

3. The Downtown Providence District Management Authority (“DPDMA”) is a body corporate and politic and an instrumentality and agency of the City of Providence, but has a legal existence distinct from the City. In exercising the powers granted to it, the DPDMA will exercise public and essential governmental functions. No part of the net earnings of the DPDMA will be distributable to, or inure to the benefit of, any private person.

4. The role of the management district is to insure the vitality of the business, residential and arts districts in downtown Providence, and to stabilize and increase the property values in the downtown area while retaining businesses and attracting new business investment. The DPDMA will have the following purposes within the management district:

(a) To provide for the cleaning of the public streets and sidewalks and the removal of snow;

(b) To provide for security; however, nothing contained in this section shall bestow or authorize any police powers on any security force with the district;

(c) To install, repair and maintain public streets and sidewalks and lighting for public streets and sidewalks;

(d) To install, repair and maintain street signs;

(e) To provide for landscaping and the repair and maintenance of public spaces;

(f) To provide for refuse collection and removal;

(g) To provide for motor vehicle parking;

(h) To sponsor and promote recreational, cultural and retail activities;

(i) To promote the development of the management district including collecting and disseminating information;

(j) To provide such other services within the management district as may be beneficial to the management district and the property owners, tenants and other occupants of the district.

5. The DPDMA shall have all of the powers and purposes as defined in R.I.G.L. §45-59-10, with three limitations:

(a) The Maximum assessment rate that may be set by the DPDMA is seven percent (7%) of the total of the real property taxes levied on the ratable real property within the management district.

(b) The DPDMA shall terminate concurrently with the termination of the management District. If a management district is reestablished, the DPDMA must be reestablished.

(c) In accordance with R.I.G.L. §45-59-20, the services provided by the DPDMA will be supplemental to the services otherwise provided by the City of Providence within the management district.

(d) The City Collector may assign, by mutual consent, any and all of the collection process to the DPDMA. Said assignment shall be defined by an agreement between the City and the DPDMA.

6. Except in accordance with limitations on the DPDMA cited in Paragraph 5, the DPDMA Shall have the power:

(a) To sue and be sued, complain and defend, in its corporate name;

(b) To have a corporate seal which may be altered at pleasure, and to use the seal by causing it, or a facsimile of the seal, to be impressed or affixed or in any other manner reproduced;

(c) To purchase, take, receive, lease, take by gift, devise or bequest, or otherwise acquire, own, hold, improve, use and otherwise deal in and with real or personal property or any interest in property, wherever situated, and without restriction as to amount;

(d) To sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of all or any part of its property and assets;

(e) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of domestic or foreign corporations, whether for profit or not for profit, limited liability companies, associations, partnerships or individuals, or direct or indirect obligations of the United States, or any other government, state, territory, governmental district or municipality or of any instrumentality thereof;

(f) To make contracts and guarantees and incur liabilities, borrow money, for periods of three (3) years or less, at such rates of interest as the district management authority may determine, issues its notes and other obligations, guarantee debts and secure any of its obligations by mortgage or pledge of all or any of its property, assets and income;

(g) To lend money for its purposes, invest and reinvest its funds, and to take and hold real and personal property as security for the payments of funds so loaned or invested;

(h) To elect or appoint officers and agents of the district management authority and to define their duties;



(i) To make an alter bylaws, not inconsistent with the petition or with the laws of the state, for the administration and regulation of the affairs of the DPDMA;

(j) To accept grants or funds from the state and from nonprofit corporations;

(k) To reconfigure the existing, approved Zones and alter the services provided in each, as the DPDMA may find necessary and appropriate, in its sole discretion;

(l) To have and exercise all other powers necessary or convenient to effect any or all purposes for which the DPDMA is created.

7. (a) The DPDMA activities will be managed by a board of directors which will consist of nine (9) members.

(b) Seven of the nine members will be appointed by the Providence Foundation as a representative of the business community as defined by R.I.G.L. §45-59-12. Four of the members appointed by the Providence Foundation must be property owners within the District. One of the directors appointed by the organization shall be a domiciliary of the management district.

(c) A minimum of five members will at all-time be property owners within the District.

(d) Two of the nine members will be appointed by the Mayor. (1) the Mayor or his or her designee; and (2) an owner of real property (not exempt from taxation by law) located within the management district.

(e) Terms for the directors will be as follows:

(1) The Mayor will assign to the persons initially appointed by him or her terms of one and two (2) years so that the terms of the directors so appointed will expire on the last days of the first and second fiscal years respectively.

(2) The Providence Foundation will assign to the seven (7) persons initially appointed by it, terms of one (1) year (as two (2) of them), two (2) years (as to two (2) of them), and three (3) years (as to three (3) of them) so that the terms of the directors so appointed will expire on the last days of the first, second and third fiscal years respectively.

(f) All officers and agents of the DPDMA will have such authority and perform such duties in the management of the DPDMA as may be provided in the bylaws, or as may be determined by resolution or vote of the board of directors, subject to any limitations on such authority contained in the bylaws.

8. In order to involve a broader cross-section of downtown stakeholders, eight non-voting board positions will be established as active, participatory board positions.

9. The DPDMA Governing Board will prepare an annual operating budget not later than sixty (60) days prior to the beginning of each fiscal year, containing:

(a) An estimate of receipts for the current fiscal year available for expenditure in the ensuing fiscal years;

(b) An estimate of receipts for the ensuing fiscal year from the special tax assessment provided for in this article;

(c) An estimate of receipts for the ensuing fiscal year from all other sources; and

(d) An estimate of expenditures for the ensuing fiscal year for the carrying on of the district management authority's activities including debt service, if any.

(e) Prior to the adoption of the budget, the DPDMA will hold a public hearing thereon at which all interested persons may be heard. Notice of the public hearing will be given by publication in the Providence Journal at least once a week for three (3) successive weeks prior to the date of the hearing.

(f) Prior to adoption, the DPDMA Governing Board shall submit a copy of the annual operating budget the Clerk of the City of Providence.

10. The DPDMA will have the power to apportion the annual operating expenses of the DPDMA by a special tax assessment amongst the owners of ratable real property, not otherwise exempt by law, located within the management district. The special tax assessments made by the DPDMA are not considered to be a tax of the City for purposes of determining the maximum lever under R.I.G.L. § 44-5-2.

11. The total of the special tax assessments levied on the ratable real property within the management district will not exceed seven percent (7%) of the total of the real property taxes levied on the ratable real property within the management district, not exempt from taxation by law, for the fiscal year of the municipality that ends within or with the fiscal year of the district management authority.

12. Properties with tax stabilized development agreements will pay DPDMA assessments based upon the full assessed value of those properties as determined by the Assessor's Office.

13. Any notes or other obligations issued by the DPDMA, their transfer and the income from the notes or obligations (including any profits made on the sale of the notes or obligations), will at all times be free from taxation by the state or any political subdivision or other instrumentality of the state.

14. Notes and other obligations of a DPDMA will not be deemed to constitute the debt or a pledge of the faith and credit of the City of Providence.

**COUNCILMAN GONCALVES AND VARGAS, (By Request):**

An Ordinance Establishing a Tax Stabilization Plan for the Property located at 136 Westminster Street.

**WHEREAS**, 136 Westminster Street, LLC (“Project Owner”) is the owner of certain real property located in the City at 136 Westminster Street, Providence, RI, Assessor’s Plat 20, Lot 366; and

**WHEREAS**, Project Owner has proposed and committed to convert the building’s empty four upper floors of office space into eight (8) residential units with one bedroom and one bathroom each; fifteen (15) residential units with one bedroom and one den, with two bathrooms; and one unit with four bedrooms and three bathrooms over two levels. The Project Owner hopes to also preserve the building through this conversion. The Project Owner will spend \$6,410,945.00 in hard costs to perform the conversion; and

**WHEREAS**, Pursuant to Rhode Island General Laws (R.I.G.L.) § 44-3-9, the General Assembly has authorized the City of Providence, acting through its City Council and subject to certain enumerated conditions, to exempt or determine a stabilized amount of taxes to be paid on account of real and personal property for a period not to exceed twenty (20) years; and

**WHEREAS**, Pursuant to the Providence Code of Ordinances, as amended, specifically Chapter 21, Article XVIII, the granting of the tax stabilization will inure to the benefit of the City of Providence and its residents by reason of:

The willingness of Project Owner to construct new or to replace, reconstruct, convert, expand, retain, or remodel buildings, facilities, fixtures, machinery, or equipment, resulting in an increase or maintenance in plant, residential housing, or commercial building investment by the Project Owner.

**NOW THEREFORE**, in consideration of the mutual agreements and promises set forth herein and other good and lawful consideration the receipt of which is hereby acknowledged, the parties agree as follows:

## SECTION 1. DEFINITIONS.

“Property” shall mean certain real property together with any and all buildings, structures, and/or improvements now or in the future located in the City at 136 Westminster Street, Providence, RI, Assessor’s Plat 20, Lot 366.

“Property Owner” shall mean any entity with a recorded legal or equitable right and/or interest in and/or to the Property, including any and all successors and assigns.

## SECTION 2. TAX STABILIZATION.

Section 2.1. Grant. The City, in accordance with R.I.G.L. § 44-3-9 and the City of Providence Code of Ordinances, does hereby grant a ten year tax stabilization in favor of the Property Owner with respect to the Property.

Section 2.2. Term. The tax stabilization term (“Term”) shall be the period commencing on December 31, 2023 and terminating on December 31, 2032. (Tax Years 2024-2033).

Section 2.3. Plan. During the Term, the stabilized amount of taxes to be paid by the Property Owner with respect to the Property, notwithstanding the valuation of the Property or the then-current rate of tax, is as follows: for the first two (2) tax years of the stabilization term, the Property Owner shall make a tax payment equal to the then-current assessment of \$1,871,200.00 set by the Tax Assessor (“Base Assessment”) multiplied by the then-current tax rate (hereinafter the “Base Assessment Tax”). The total base tax amount of the then-current tax rate is equal to \$65,679.12. For each tax year thereafter, the Property Owner will pay the Base Assessment Tax plus a percentage of the taxes due and owing on the difference between the Base Assessment and then-current assessed value of the Property multiplied by the then-current rate. See “Tax Stabilization Plan” incorporated herein as if fully reproduced and attached hereto and as Exhibit A.

Section 2.4. Payment Deadlines. During the Term and in accordance with the tax stabilization plan outlined therein, stabilized tax payments shall be made in either a lump sum during the first quarter of the applicable tax year or in equal quarterly installments at the discretion of the Property Owner. If the Property Owner elects to make quarterly installments, each quarterly installment shall be due on the same date that quarterly taxes are due for all other taxpayers in the City of Providence.

Section 2.5. Obligation of Property Owner to Make Payment. During the Term and in accordance with the tax stabilization plan outlined herein, stabilized tax payments shall be an obligation of the Property Owner.

Section 2.6. Non-Receipt of Stabilized Tax Bill. Failure by the City to send or failure by the Property Owner to receive a stabilized tax bill does not excuse the nonpayment of the stabilized tax nor affect its validity or any action or proceeding for the collection of the tax in accordance with this stabilization, an Agreement formed hereunder, or otherwise.



Section 2.7. Recording of Plan, Running with Land. The Property Owner shall cause this tax stabilization plan to be recorded at its expense in the City's official public land evidence records. This recording shall be construed to provide a complete additional alternative method under contract law for the securitization of payments due and owing under this stabilization and shall be regarded as supplemental and in addition to the powers conferred by other state and local laws.

### SECTION 3. ADDITIONAL REQUIREMENTS OF STABILIZED PROJECTS.

Section 3.1. Commencement of Performance. Construction or rehabilitation shall commence within eighteen (18) months and shall obtain a Certificate of Occupancy from the Department of Inspections and Standards within thirty-six (36) months of the effective date of said agreement. Property Owners who fail to meet either of these deadlines will be required to retroactively pay the difference between their actual stabilized tax payments and what they would have paid if ineligible for the specified tax considerations. The owner may, eighteen (18) months prior to the applicable deadline, submit a request to the city council for approval of an extension to such applicable deadline.

Section 3.2. Permits and Certificates of Occupancy. Property Owner shall obtain all permits and certificates of occupancy as required by state and local law in connection with any and all intended construction or rehabilitation.

Section 3.3. MBE/WBE. During the Term, the Property Owner shall comply with any and all requirements under Chapter 21, Article II, Section 52 of the Providence Code of Ordinances as it pertains to Minority and Women Business Enterprises.

Section 3.4. Internal Revenue Service reporting. Except as provided under R.I.G.L. § 28-42-8, any person performing services at the Property shall annually receive either a W-2 statement or an IRS Form 1099.

Section 3.5. First Source. During the Term, the Property Owner shall enter into a First Source Agreement with the Director of First Source Providence in accordance with Chapter 21 Article III1/2 of the Providence Code of Ordinances, including at least one percent (1%) of the total amount of discounted taxes to be directed to the first source trust fund, per Section 21-95.

Section 3.6. Equal Employment. During the Term, the Property Owner shall work with the City's Office of Human Resources, Division of Equal Employment Opportunity to ensure the City's goals to prohibit discrimination against qualified individuals based on their status as protected veterans or individuals with disabilities, and prohibit discrimination against all individuals based on their race, color, religion, sex, sexual orientation, gender identity or national origin are met. Moreover, the Property Owner will take affirmative action to employ and advance in employment individuals without regard to race, color, religion, sex, sexual orientation, gender identity, national origin, protected veteran status or disability.

Section 3.7. “Buy Providence” Initiative. During the Term, the Property Owner shall use best efforts to ensure that construction materials are purchased from economically competitive and qualified vendors located in the city of Providence. In furtherance of this effort, the Property Owner will work with the city to develop a list of Providence vendors and subcontractors in order to create a preferred vendor list of qualified and economically competitive vendors for the construction of the project. Furthermore, once the Property Owner constructs the development, the Property Owner will use good faith efforts to conduct ongoing business with and provide preference to economically competitive and qualified Providence businesses.

Section 3.8. Apprenticeship. The Property Owner shall ensure that one hundred percent (100%) of the hours worked on the project shall be performed by all trade construction contractors and subcontractors who have or are affiliated with an apprenticeship program as defined in 29 C.F.R. § 29 et seq. Additionally, the Property Owner shall ensure that all bidding documents for the work to be performed on the Eligible Project includes express and conspicuous language evidencing the requirement found in this subsection.

As part of its contract with the construction manager and/or general contractor, the Property Owner shall require that not less than ten percent (10%) of the total hours worked by the contractors’ and subcontractors’ employees on the project are completed by apprentices registered in the aforementioned apprenticeship programs. Failure to comply with or meet the requirements of this subsection shall be a material violation of the Property Owner’s obligations under this chapter.

The Property Owner, its Prime Contractor, or any other person/entity authorized by the Property Owner, may petition the City of Providence’s Director of Planning and Development, or his/her designee to adjust the requirements found in this subsection to a lower percentage upon a showing that:

- (A) A trade or field does not have an apprenticeship program or cannot produce members from its program capable of performing the scope of work within the contract; or
- (B) The size and scope of the work will not allow for the contractor to comply with apprenticeship ratio requirements for the craft affected; or
- (C) For any other non-economic justifiable reason that demonstrates good cause.

Accompanying the petition mentioned in this sub-section, the petitioning entity must provide contemporary evidence of the efforts taken to comply with this section, including but not limited to the bidding and responsive documents for the scopes of work for which the petitioning entity is seeking an exemption.

Section 3.9. Project Compliance. This stabilization shall in no way confer that the underlying project (construction or rehabilitation) is either compliant with the Providence Zoning Ordinance or has received the necessary approvals from any board or commission, including (but not limited to) the Historic District Commission, the Downtown Design Review Committee, the Capital Center Commission, the City Plan Commission, the Zoning Board of Review, or the I-195 Redevelopment Commission (as applicable).

Section 3.10. Prohibited and Restricted Uses. The following uses, as defined by Chapter 27 of the Providence Code of Ordinances, shall not be permitted on the Property during the Term: Adult use (including adult bookstore/retail, adult arcade, adult cabaret, adult motion picture theater, and adult hotel/motel), compassion center or cultivation center, contractor storage yard, fraternity or sorority, landfill, materials processing of scrap metal, storage yard (outdoor), and the retail use for gun stores, payday lending, or check-cashing operations. The following uses, as defined by Chapter 27 of the Providence Code of Ordinances, shall not exceed twenty-five percent (25%) of the usable square footage of the Property during the Term: bar, nightclub, and retail sales of alcohol.

Section 3.11. City of Providence Parks and Recreation Trust Fund. The Property Owner shall make annual payments to the Fund in the amount of seven percent (7%) of the estimated total of taxes abated (as shown in the Tax Assessor's Fiscal Note) amortized over the Term. Notwithstanding anything mentioned in this subsection, the Property Owner shall pay \$1,000.00 in the Fund annually in the tax years in which the Property Owner pays a base assessment tax. Said annual payments will be payable within thirty (30) days of receipt of an invoice for the same from the Office of the Tax Assessor. If, for any reason, this Ordinance is retroactively revoked, payments to the fund shall remain and will not be forfeited due to a default.

Section 3.12. Monitoring Fee. Within thirty (30) days of receiving a statement from the Tax Assessor, the Property Owner shall remit a monitoring/compliance fee to the City in the amount of 0.01 percent of the total project costs as presented in the Property Owner's application for each respective tax year during the term of this stabilization.

Section 3.15. Tax Appeals. Property Owner waives the right to appeal the base assessment as determined by the Tax Assessor for the duration of the Tax Stabilization Agreement.

#### SECTION 4. TRANSFER OF PROPERTY.

Section 4.1. Transfer Generally. Stabilized tax payments shall be an obligation of the Property Owner during any of the tax stabilization terms as defined in Section 2 above and in accordance with the tax stabilization plan outlined therein, without regard to any transfer of the Property. Additionally, in accordance with Section 2.7, the burdens and benefits of this stabilization will run with the land, and as for payment of taxes shall run in favor of the City regardless of any transfer of ownership. The Property Owner must provide prior written notice to the City before any transfer of the Property so that the City may determine, in its sole discretion, as to whether or not this stabilization will continue.

Section 4.2. Transfer to Tax Exempt Entities. In the event that the Property Owner transfers the Property to a tax-exempt entity, this stabilization shall be void ab initio and any entity holding an equitable or legal interest in the Property on or after the effective date of this stabilization shall be jointly and severally liable for the full taxes due and owing from said effective date forward.



Section 4.3. Post-Expiration Transfers. In the event that the Property Owner transfers the Property to a tax-exempt entity within five years from the end of any tax stabilization term, as defined in Section 2.2 above, any and all Property Owners will pay the following: five percent (5%) of the sale price in said transfer if sold to a tax-exempt entity in the first year following the end of the term; four percent (4%) of the sale price in said transfer if sold to a tax-exempt entity in the second year following the end of the term; three percent (3%) of the sale price in said transfer if sold to a tax-exempt entity in the third year following the end of the term; two percent (2%) of the sale price in said transfer if sold to a tax-exempt entity in the fourth year following the end of the term; and one percent (1%) of the sale price in said transfer if sold to a tax-exempt entity in the fifth year following the end of the term.

## SECTION 5. ANNUAL PROGRESS REPORT.

Section 5.1. Reporting Generally. The Property Owner shall provide monthly reports to the City Council, or the Council's designee, and in such instance that the Property is within the jurisdiction of the I-195 Commission then the Commission as well, on its progress in complying with the provisions of this stabilization.

Section 5.2. Reporting Requirements. The reporting format shall be provided by the City Council of Providence in its sole discretion to document construction-based employment information and demographics related to the terms of this stabilization. If the Property Owner, its developer and/or other person/entity authorized by the Property Owner, does not timely submit their monthly reports to the City Council, or its designee, the City Council or its designee shall notify the Property Owner. The Property Owner shall have ten (10) days thereafter to provide the information to the City or its designee. The project site owner, the Director of Planning and Development, the Director of First Source, and a representative of the third-party entity monitoring apprenticeship requirements shall annually report to the City Council on progress in complying with the provisions of this stabilization, including but not limited to, sections 2 and 3. Specifically, its report shall include a performance report on construction or rehabilitation with evidence of final construction costs, status of stabilized tax payments, and evidence of compliance with Section 3. Upon receipt and review, the City Council may require and request additional information.

## SECTION 6. DEFAULT.

The following events shall constitute an event of default:

- (A) Failure of the Property Owner to pay any amount due under or with respect to Section 2; or
- (B) Failure of the Property Owner to record a Notice of this stabilization as required by and in accordance with Section 2; or
- (C) Failure of the Property Owner to meet any of the performance obligations set forth in Section 3; or
- (D) Failure of the Property Owner to annually report as required by Section 5; or
- (E) Failure of the Property Owner to notify the City in writing within thirty (30) days of the transfer of the Property; or



- (F) Transfer of the Property by the Property Owner outside of the terms of this stabilization; or
- (G) Failure of the Property Owner to comply with any other obligation or promise contained within any section or subsection of this stabilization; or
- (H) Failure of the Property Owner to comply with all state and local law regarding building and property maintenance codes, zoning ordinances, and building and/or trade permits; or
- (I) Failure of the Property Owner to waive as set forth in Section 8.4; or
- (J) Failure of the Property Owner to remain current on any and all other financial obligations to the City of Providence.

## SECTION 7. NOTICE AND CURE.

Section 7.1. Notice and Cure Period. In event of potential Default (as defined in Section 6), the City Solicitor (or outside counsel hired by the City Council) shall provide written notice to the Property Owner of such potential Event of Default ("First Notice") and notify the Property Owner that it shall have sixty (60) days, from the date the Notice herein is sent, to cure any Event of Default pursuant to this stabilization ("Initial Cure Period"). If said Event of Default is not cured within the Initial Cure Period, then the City Solicitor (or outside counsel hired by the City Council) shall notify the Property Owner in writing ("Second Notice") that this stabilization is terminated and that a bill will be sent out by the Tax Assessor sixty (60) days from the date of the Second Notice. Said bill will be for the abated taxes to date and those amounts including, but not limited to, any amounts of taxes due and owing but not paid, interest, penalties, assessments, and fees associated therewith ("Delinquency Bill").

The Property Owner may petition the City Council in writing for additional time beyond the Initial Cure Period in order to cure any alleged Event of Default ("Extended Cure Period"). Once filed with the City Clerk, a petition requesting an Extended Cure Period will toll the time period between the Second Notice and the issuance of the Delinquency Bill until the petition is either approved, denied, or withdrawn. An indefinite continuance shall constitute a denial.

Section 7.2. Agreed Upon Address for Purposes of Written Notice. All notices, requests, consents, approvals, and any other communication which may be or are required to be served or given (including changes of address for purposes of notice) shall be in writing and shall be sent registered or certified mail, or by nationally recognized overnight courier (such as Federal Express or UPS) and addressed to the following parties set forth below:

## SECTION 8. RIGHTS AND REMEDIES.

Failure or delay on the part of the City to exercise any rights or remedies, powers or privileges at any time under this stabilization or under any state or local law shall not constitute a waiver thereof, nor shall a single or partial exercise thereof preclude any other or further exercise thereof or the exercise of any other right, remedy, power of privilege thereunder.

Section 8.4. Property Owner's Rights. During the tax stabilization term as defined in Section 2.2, the Property Owner agrees to waive and forever forgo any and all of its rights and privileges under R.I.G.L. § 44-5-26 and -27, as it pertains to the Tax Payments due and owing pursuant to this stabilization, unless there is a loss of use of the Property as a result of fire, flood, earthquake, or other act of God. Nothing herein shall be construed to limit the right of the Property Owner to pursue its rights and remedies under the terms of this stabilization.

## SECTION 9. MISCELLANEOUS TERMS.

Section 9.1 Severability. The sections of this stabilization are severable, and if any of its sections or subsections shall be held unenforceable by any court of competent jurisdiction, the decision of the court shall not affect or impair any of the remaining sections or subsections.

Section 9.2. Applicable Law. This stabilization shall be construed under the laws of the State of Rhode Island, the City of Providence Home Rule Charter, and the City of Providence Code of Ordinances, as amended.

Section 9.3. Entire Agreement; Amendments. This stabilization and all attachments, addenda, and/or exhibits attached hereto shall represent the entire agreement between City and the Property Owner. This stabilization shall not be modified, amended, extended or altered in any way by oral representations made before or after the execution of this stabilization. Any and all modifications, amendments, extensions or alterations must be in writing duly executed by all parties, and passed by City Council.

Section 9.4. Effective Date. This stabilization shall take effect upon passage of this Ordinance by the Providence City Council, approval by the Mayor (or the Ordinance otherwise becoming effective). Immediately following the Effective Date, the Property Owner shall record this Ordinance with the City's official public land evidence records.

**COUNCILMAN VARGAS AND COUNCILWOMAN GRAVES, (By Request):**

An Ordinance Establishing a Tax Stabilization Plan for the Property Located at 1836 Westminster Street.

**WHEREAS**, Postal Kitchen, LLC ("Project Owner") is the owner of certain real property located in the City at 1836 Westminster Street, Assessor's Plat 35, Lot 329; and

- (A) The willingness of Project Owner to construct new or to replace, reconstruct, convert, expand, retain, or remodel buildings, facilities, fixtures, machinery, or equipment, resulting in an increase or maintenance in plant, residential housing, or commercial building investment by the Project Owner.

**NOW THEREFORE**, In consideration of the mutual agreements and promises set forth herein and other good and lawful consideration the receipt of which is hereby acknowledged, the parties agree as follows:

**SECTION 1. DEFINITIONS.**

"Property" shall mean certain real property together with any and all buildings, structures, and/or improvements now or in the future located in the City at 1836 Westminster Street, Assessor's Plat 35, Lot 329.

"Property Owner" shall mean any entity with a recorded legal or equitable right and/or interest in and/or to the Property, including any and all successors and assigns.



## SECTION 2. TAX STABILIZATION.

Section 2.1. Grant. The City, in accordance with R.I.G.L. § 44-3-9 and the City of Providence Code of Ordinances, does hereby grant a five (5) year tax stabilization in favor of the Property Owner with respect to the Property.

Section 2.3. Plan. During the Term, the stabilized amount of taxes to be paid by the Property Owner with respect to the Property, notwithstanding the valuation of the Property or the then-current rate of tax, is as follows: for the first tax year of the stabilization term, the Property Owner shall make a tax payment equal to the then-current assessment of \$300,400.00, set by the Tax Assessor ("Base Assessment") multiplied by the then-current tax rate (hereinafter the "Base Assessment Tax"). The total base tax amount of the then-current tax rate is equal to \$10,544.04. For each tax year thereafter, the Property Owner will pay the Base Assessment Tax plus a percentage of the taxes due and owing on the difference between the Base Assessment and then-current assessed value of the Property multiplied by the then-current rate. See "Tax Stabilization Plan" incorporated herein as if fully reproduced and attached hereto and as Exhibit A.

Section 2.4. Payment Deadlines. During the Term and in accordance with the tax stabilization plan outlined therein, stabilized tax payments shall be made in either a lump sum during the first quarter of the applicable tax year or in equal quarterly installments at the discretion of the Property Owner. If the Property Owner elects to make quarterly installments, each quarterly installment shall be due on the same date that quarterly taxes are due for all other taxpayers in the City of Providence.

Section 2.5. Obligation of Property Owner to Make Payment. During the Term and in accordance with the tax stabilization plan outlined herein, stabilized tax payments shall be an obligation of the Property Owner.

Section 2.7. Recording of Plan, Running with Land. The Property Owner shall cause this tax stabilization plan to be recorded at its expense in the City's official public land evidence records. This recording shall be construed to provide a complete additional alternative method under contract law for the securitization of payments due and owing under this stabilization and shall be regarded as supplemental and in addition to the powers conferred by other state and local laws.



### SECTION 3. ADDITIONAL REQUIREMENTS OF STABILIZED PROJECTS.

Section 3.4. Internal Revenue Service reporting. Except as provided under R.I.G.L. § 28-42-8, any person performing services at the Property shall annually receive either a W-2 statement or an IRS Form 1099.

Section 3.5. First Source. During the Term, the Property Owner shall enter into a First Source Agreement with the Director of First Source Providence in accordance with Chapter 21 Article III1/2 of the Providence Code of Ordinances, including at least one percent (1%) of the total amount of discounted taxes to be directed to the first source trust fund, per Section 21-95.

Rather, this stabilization shall be construed to provide a complete additional alternative method under contract law for the collection of taxes, and shall be regarded as supplemental and in addition to the powers conferred by other state and local laws.

Section 8.3. Waiver. Failure or delay on the part of the City to exercise any rights or remedies, powers or privileges at any time under this stabilization or under any state or local law shall not constitute a waiver thereof, nor shall a single or partial exercise thereof preclude any other or further exercise thereof or the exercise of any other right, remedy, power of privilege thereunder.

Section 8.4. Property Owner's Rights. During the tax stabilization term as defined in Section 2.2, the Property Owner agrees to waive and forever forgo any and all of its rights and privileges under R.I.G.L. § 44-5-26 and -27, as it pertains to the Tax Payments due and owing pursuant to this stabilization, unless there is a loss of use of the Property as a result of fire, flood, earthquake, or other act of God. Nothing herein shall be construed to limit the right of the Property Owner to pursue its rights and remedies under the terms of this stabilization.

## SECTION 9. MISCELLANEOUS TERMS.

Section 9.1 Severability. The sections of this stabilization are severable, and if any of its sections or subsections shall be held unenforceable by any court of competent jurisdiction, the decision of the court shall not affect or impair any of the remaining sections or subsections.

Section 9.2. Applicable Law. This stabilization shall be construed under the laws of the State of Rhode Island, the City of Providence Home Rule Charter, and the City of Providence Code of Ordinances, as amended.

Section 9.3. Entire Agreement; Amendments. This stabilization and all attachments, addenda, and/or exhibits attached hereto shall represent the entire agreement between City and the Property Owner. This stabilization shall not be modified, amended, extended or altered in any way by oral representations made before or after the execution of this stabilization. Any and all modifications, amendments, extensions or alterations must be in writing duly executed by all parties, and passed by City Council.

Section 9.4. Effective Date. This stabilization shall take effect upon passage of this Ordinance by the Providence City Council, approval by the Mayor (or the Ordinance otherwise becoming effective). Immediately following the Effective Date, the Property Owner shall record this Ordinance with the City's official public land evidence records.

**SECTION II.** The City Council hereby authorizes the Mayor and the Director of Finance acting on behalf of the City, to take the appropriate steps to acquire the capital items and to finance the same through the Lease and related documents (the "Financing Documents"), in a principal amount not to exceed Twenty Million Dollars (\$20,00,000), subject to annual appropriation therefor by the City.

**SECTION III.** The form and other details, terms and conditions of the Financing Documents shall be fixed by the Mayor and the Director of Finance.

**SECTION IV.** The Mayor and the Director of Finance are hereby authorized to enter into the Financing Documents and said officers are hereby authorized and instructed to take all actions, and to execute and deliver the Financing Documents and any related agreements, certificates and other documents in such form as they may deem necessary or desirable to implement the lease financing of the capital items. Such officers are also authorized to take all action, on behalf of the City, necessary to insure that interest component of the lease payments will be excludable from gross income for federal income tax purposes and to refrain from all actions which would cause the interest component of the Lease to become subject to federal income taxes.



**SECTION V.** This ordinance is an affirmative action of the City Council of the City of Providence toward the issuance of one or more lease purchase agreements or schedules thereto in accordance with the purposes of the laws of the State of Rhode Island. This ordinance constitutes the City's declaration of official intent pursuant to Treasury Regulation Section equipment paid on or after the date which is sixty (60) days prior to the date of this ordinance, but prior to the issuance of the lease purchase agreement. Such amounts to be reimbursed shall not exceed \$20,000,000 and shall be reimbursed not later than eighteen (18) months after (a) the date on which the expenditure is paid, or (b) the date the Project is placed in service or abandoned but in no event later than three (3) years after the date the expenditure is paid.

**SECTION VI.** This ordinance shall take effect on passage.

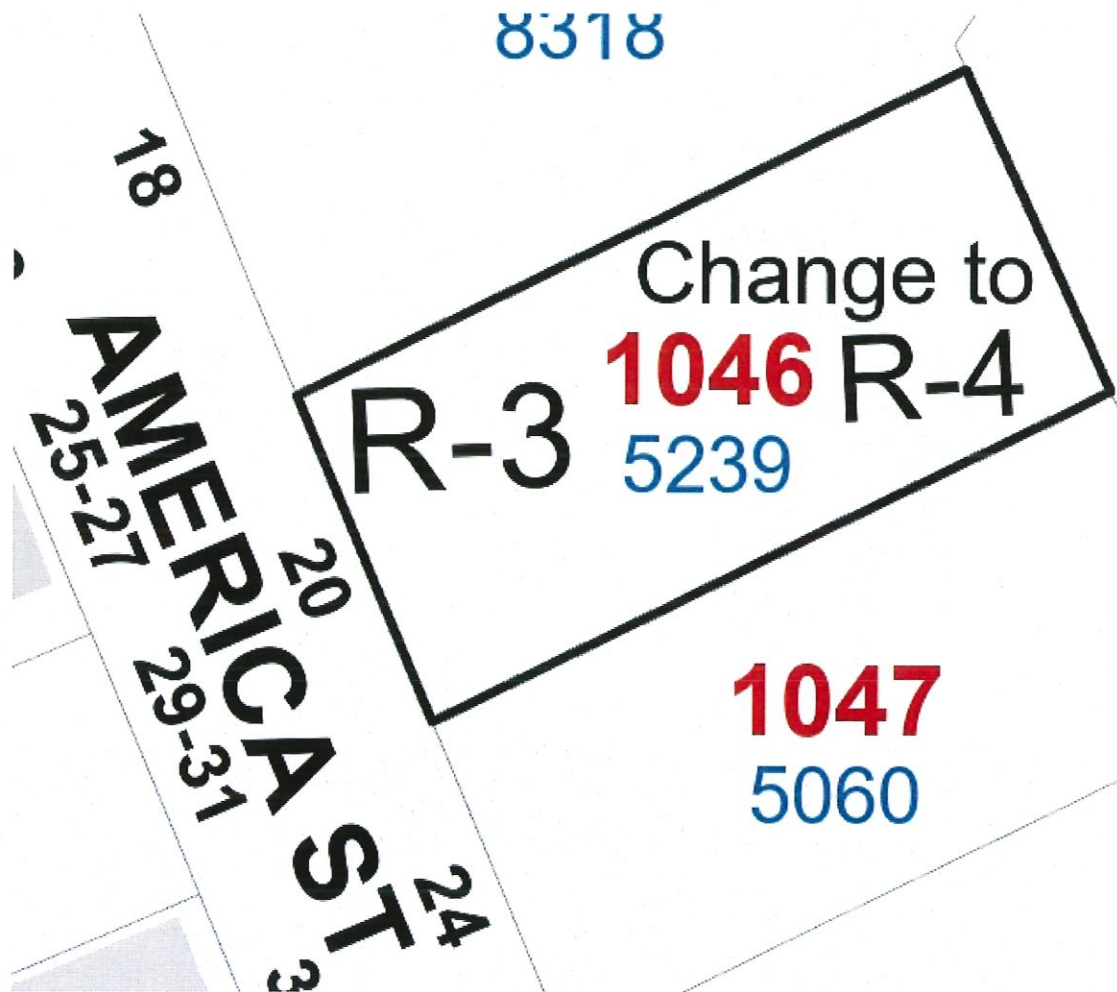

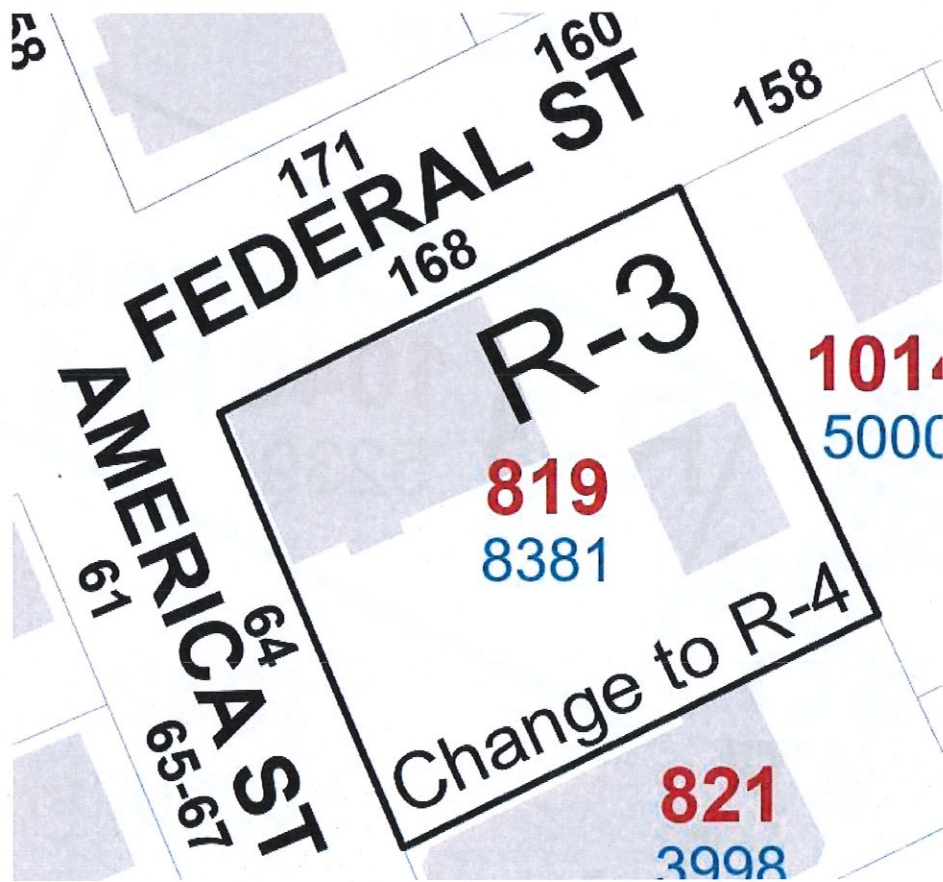

**WHEREAS**, Meeting the developmental, mental, emotional, and behavioral health needs of children is critical to their well-being and, therefore, critical to the well-being of our state and city; and

**WHEREAS**, There are approximately 209,785 children under age 18 living in Rhode Island, with approximately 41,021 residing in the City of Providence; and

**WHEREAS**, Children's mental health can influence children's behavior and daily functioning in school, at home, and in the community; and

**WHEREAS**, According to the RI Department of Health, in 2023, 36% of Rhode Island high school students reported feeling sad or hopeless for more than two weeks, and 9% reported attempting suicide one or more times during the year. Additionally, in 2022, there were 3,625 emergency department visits and 2,271 hospitalizations of Rhode Island children with a primary diagnosis of mental disorder; and

**WHEREAS**, According to the RI Department of Education, more than 70% of Providence students reported that stress interferes with their ability to participate in school, and 27% of Providence middle school students worry about violence in school; and

**WHEREAS**, Children in need of mental health care often wait for months to receive care, and children who need intensive residential care are often stuck in hospital-level care or placed in out-of-state residential programs to receive treatment; and

**WHEREAS**, In 2023, according to the RI Department of Children, Youth, and Families, approximately 408 Providence children were found to be victims of abuse or neglect and in need of services; and

**WHEREAS**, Rhode Island is alleged to have violated the Olmstead Act by not ensuring that children receive the least restrictive services to meet their developmental and behavioral health care needs.

- (b) Review statewide approaches for different services including bulky waste, e-waste, and mattress removal along with associated costs.
- (c) Review customer service data to identify areas for improvement and goals for future targets
- (d) Review the current contractual requirements and make recommendations for changes that should be incorporated into the next RFP.
- (e) Issue a report of recommendations to the City Council.


