Gentlemen:

The Providence Redevelopment Agency, in accordance with the provisions of Paragraph 8, Chapter 68-11 of the Ordinances of the City of Providence approved March 13, 1968 as amended by Chapter 1798 of the Ordinances of the City of Providence approved November 7, 1966 and Title 45, Chapter 32, Section 4 of the General Laws of Rhode Island 1956, hereby reports concerning the proposed sale of real property within the Mount Hope Project R. I. R-18.

The Agency proposes the sale of Parcel 5 designated as Lot 107 on City Assessor's Plat 5 and further delineated on attached map within the Mount Hope Project for the disposition price of \$100.00 to Mr. Gary Movsovitze and Mr. Lawrence Popkin d/b/a R. I. Aquarium Center. The parcel will be developed as an adjacent commercial parking area in accordance with plans approved by the Providence Redevelopment Agency.

Also, the Providence Redevelopment Agency, in accordance with the provisions of Paragraph 10, Chapter 1971-24 of the Ordinances of the City of Providence, approved May 10, 1971, as amended by Chapter 69-47 of the Ordinances of the City of Providence, approved November 28, 1969, and Title 45, Chapters 31-33 of the General Laws of Rhode Island 1956, hereby reports concerning the proposed sale of real property within the West Broadway NDP, A2-1, Year II.

The Agency proposes the sale of Parcel 2 designated as Lots 127, 128 and 659 on City Assessor's Plat 33 and further delineated on attached map within the West Broadway Project A2-1, Year II for the disposition price of \$2,400.00 to Mr. Vincent J. Mesolella, Jr. The parcel will be developed for residential reuse in accordance with plans approved by the Providence Redevelopment Agency.

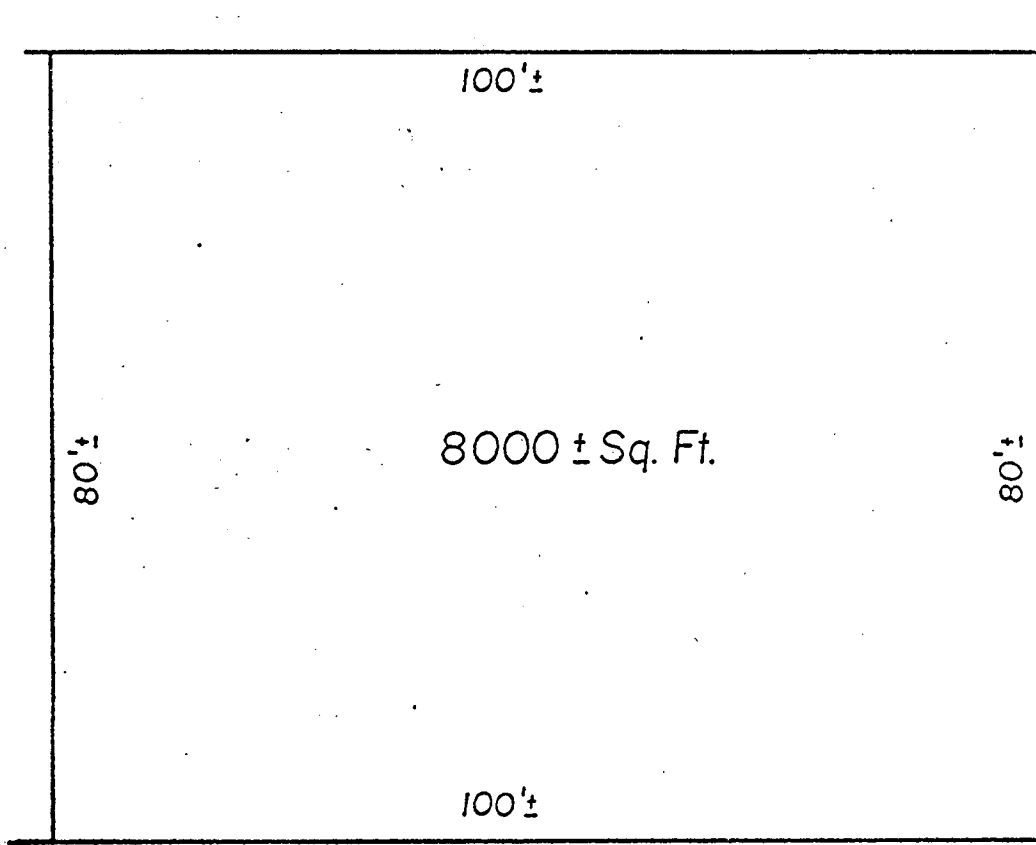

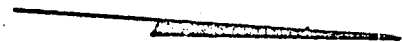
