RESOLUTION OF THE CITY COUNCIL

No. 1

Approved January 11, 1982

WHEREAS, A vacancy exists in the Office of One Councilman from the Fifth Ward in the City of Providence, Rhode Island, caused by the death, on December 21, 1981, of Ralph Fagnoli.

WHEREAS, The said vacancy did occur more than One Hundred Eighty (180) Days before the time of the holding of the next succeeding regular City Election, and

WHEREAS, In accordance with the provisions of Section 3.4 of the Charter of the City of Providence, Rhode Island, and by Section 1 of Chapter 2864 of the Public Laws of 1951, approved May 1, 1951, it is mandatory that a Special Election for the purpose of filling such vacancy be held within ninety (90) days of the date of the occurrence of such vacancy, and

WHEREAS, Section 17-15-4 of the General Laws of the State of Rhode Island provides a primary election for the nomination of such city or town officials shall be held and the local board shall fix the date thereof; provided, however, that said primary election shall have been held by the thirtieth (30th) day preceding the date fixed for said election,

NOW, THEREFORE, BE IT RESOLVED, By the City Council of the City of Providence, Rhode Island, that, in compliance with the provisions of the governing statutes, the said City Council does hereby order a Special Election to be held for the purpose of filling the vacancy in the Office of One Councilman from the Fifth Ward of the City of Providence, Rhode Island, caused by the death, on December 21, 1981, of Ralph Fagnoli, and

BE IT FURTHER RESOLVED, That the Board of Canvassers and Registration of the City of Providence, Rhode Island, and all other officers whose duty it is to prepare for elections, are hereby requested and notified to make such preparations for said election as required by law, and

BE IT FURTHER RESOLVED, That the City Clerk is directed to cause a certified copy of this Resolution to be transmitted to the Board of Canvassers and Registration of the City of Providence, Rhode Island; and that a duly certified copy of this Resolution be transmitted to the State of Rhode Island Board of Elections and to the Secretary of State of Rhode Island.
