



WHEREAS, as recent as two months ago, the City Controllers Department advised the School Department that there appeared to be an even greater deficit than in any of the past years, and,

WHEREAS, the City of Providence has requested an explanation of the deficit and has been given no satisfactory answers.

NOW THEREFORE BE IT RESOLVED, His Honor the Mayor is authorized to engage the firm of Peat, Marwick, Mitchell & Co., Certified Public Accountants, for the purpose of performing an analysis and audit to determine the status of the expenditures and encumbrances of the School Department to date.

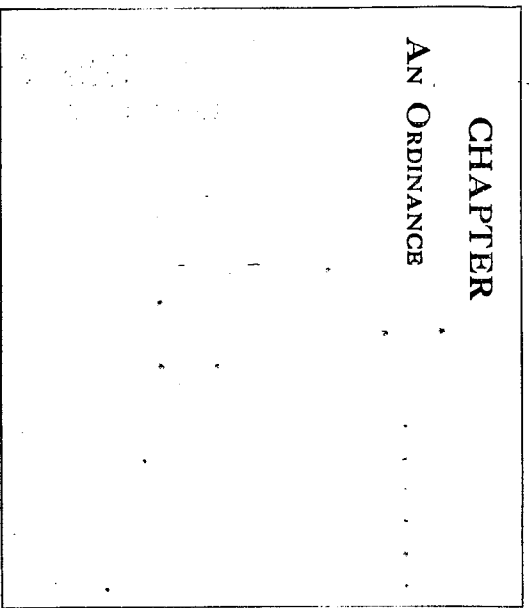
