## IN GENERAL ASSEMBLY

JANUARY SESSION, A. D. 19 72.

### AN ACT

REPEALING CERTAIN SECTIONS OF CHAPTER 10 OF THE GENERAL LAWS OF RHODE ISLAND, 1956, ENTITLED "CANVASSING THE LISTS OF QUALIFIED ELECTORS", AND AMENDING SECTION 26 OF SAID CHAPTER 10.

*It is enacted by the General Assembly as follows:*

SECTION 1. The following sections of Chapter 10 of the General Laws of Rhode Island, 1956, entitled "Canvassing the Lists of Qualified Electors" are hereby repealed:

- "17-10-2. Maintenance of registration--Mail Canvass and Inactive File.
- 17-10-4. Publication of Preliminary Lists.
- 17-10-5. Defacement of Posted Lists.
- 17-10-9. Notice of Striking of Names."

SEC. 2. Section 17-10-26 of said General Laws of Rhode Island, 1956, entitled "Certified Copies of Lists of Persons Voting" is hereby amended as follows:

"17-10-26. Certified Copies of Lists of Persons Voting.--Every clerk of a local board upon payment or tender of his legal fees, shall furnish to any one demanding the same, a certified copy of any list of voters whose votes have been given in any election."

SEC. 3. This Act shall take effect upon its passage.
