COUNCILWOMAN DIRUZZO nominates WILLIAM G. GRANDE, ESQUIRE of Providence.


This Nomination is seconded by COUNCILMAN DELUCA.


Dear Michael:



### **William G. Grande, Esquire**

This evening we the friends and family of Bill Grande join to honor this individual as he receives the 1992 Merit and Achievement Award from the Silver Lake Annex Community Center. This award is a tribute to his dedication, commitment, and contributions made to the community.

William G. Grande Sr. was born in Providence, the son of Angelo and Teresina Grande. Bill is married to the former Olga Lancellotti and is the father of seven children and the grandfather of six. Bill Grande was educated at Classical High in Providence, Providence College and Northeastern Law UNIVERSITY.

As a practicing attorney for over 60 years, Bill has served the State of Rhode Island and the community as a probate judge, a state representative, as a special assistant attorney general and as the chief of the attorney general's crime prevention bureau. In 1974, Bill founded CLAMP, the first effective crime prevention program in Providence.

Bill Grande has truly been committed to the community as a whole, serving as a member of the Providence Plantations Club, the Smithfield Lodge of Elks #2329, serving as justice of the forum, the Rhode Island Hemophilia Foundation as executive director and volunteer attorney. He serves as an honoray life member of the American Bar and Rhode Island Bar Associations as well as being a member of the United States Supreme Court Bar. In addition to his professional memberships and affiliations, Bill has served as past president of the Saint Bartholomew's Society, the Silver Lake Lions Club and for 18 years served as president of the Rhode Island Hemophilia Association.

A standing tribute to Bill Grande is the success of his family, which includes his daughter Corinne, an associate justice of the Rhode Island Superior Court, and the size of his extended family. Since 1952, Bill has served as a foster parent to 82 foster children and presently is the foster father of 13 children living in Santo Domingo, Santo Diego, Thailand, Columbia, Honduras, Nepal and Guatemala. Most recently, he visited five of his foster children in Santo Domingo.

Service, dedication, commitment, love and family are certainly all outstanding qualities of our honoree. He is one honored for his warmth, humanity and generosity. This award is being bestowed this evening upon a truly deserving individual.
