

Dear Mr. President and Council Members:

I am requesting a limited exemption from the City Charter's residency requirement for Joseph Agostinelli. I have appointed Mr. Agostinelli to serve in the position of Special Assistant. The position of Special Assistant is responsible for a wide variety of duties and requires the type of management background and knowledge that only Mr. Agostinelli possesses.

Prior to his appointment, the position was held by Mr. Henry Fazzano, who during his tenure as Special Assistant served as the interim Director of three City Departments. As interim Tax Collector, Mr. Agostinelli has displayed the management qualities necessary to meet the requirements of this very demanding position.

This appointment also lacks any type of tenured status and thus the appointee serves at the pleasure of the Mayor.

Mr. Agostinelli has also indicated he shall terminate his employment with the City on December 31, 1990.

After having conducted a diligent search, I have been unable to find anyone currently residing in the City who possesses the background, knowledge or ability to serve in the position of Special Assistant.

Accordingly, due to the finite nature of his employment, the untenured status of the position, and Mr. Agostinelli's unique abilities, I, am respectfully requesting a limited exemption for Mr. Joseph Agostonelli from the City Charter's residency requirement, to expire on December 31, 1990.
