



Dear Councilman Alprin:

In a letter dated October 7 from Mr. Vincent Vespia, City Clerk, it was explained that the City Property Committee desired further information regarding the proposed lease between the City of Providence and the Rhode Island Episcopal Convention.

At the time land was condemned for the development of Scituate Reservoir in 1915, there was a total of 1200 buildings located within the condemned area including six cotton mills, one power house and car barn, 414 dwelling houses, 7 schoolhouses, and 6 churches. One of the church properties acquired belonged to the Episcopal Diocese of Rhode Island.

On October 1, 1948, the City Council authorized the Mayor to sign a lease between the City of Providence and the Rhode Island Episcopal Convention to enable them to erect Trinity Church on land owned by the City for water supply purposes in the village of North Scituate. This church was to replace the original one condemned by the City under the 1915 Act. The parcel contained 62,500 sq. ft. and the term of the lease was for a period of 50 years.

Under City Council Resolution #352 approved August 5, 1960, another lease was authorized for a period of 50 years between the City and the Rhode Island Episcopal Convention for an additional parcel adjacent to that one leased for the church which contained 37,258.22 sq. ft. This second parcel would enable them to build a school at a site immediately adjacent to the church.



The proposed lease requested by the Rhode Island Episcopal Convention which is under consideration by the Council is to be used for a parking lot by the members of the Trinity Church. It will eliminate parking along the heavily traveled Route 6 in the vicinity of North Scituate. The use of this parking lot, no doubt, will exist as long as the church and school occupy their present site and for that reason, the term of the lease is for a period similar to the terms of the other two leases granted to the Episcopal Diocese.

This is similar to a request received from St. Joseph's Roman Catholic Church Corp. in 1955 who wanted to lease property owned by the City of Providence for water supply purposes in order to obtain a parking lot adjacent to their church in North Scituate. Under Council Resolution #468 approved August 5, 1955, the Mayor was authorized to execute a lease between the City of Providence and St. Joseph's Roman Catholic Church Corp. of North Scituate for a period of 50 years to enable them to build a parking lot to eliminate the congestion on Route 6 and Route 116 in the vicinity of North Scituate.

The Scituate watershed contains 92.8 sq. mi. and the City owns in fee slightly under 24 sq. mi. The purpose in acquiring these extensive holdings on the watershed was to obtain marginal protection around the reservoirs and prevent any pollution from entering our supply.

LEASE

This indenture of lease made and entered into on this 1st day of August, in the Year of Our Lord, 1964, by and between the City of Providence, a municipal corporation created by the General Assembly of the State of Rhode Island, of the first part, Lessor, and the Rhode Island Episcopal Convention, a Rhode Island corporation, party of the second part, Lessee.

W I T N E S S E T H:

That the said Lessor, for and in consideration of the rents and covenants hereinafter specified, and contained, on the part of said Lessee, its successors, administrators and assigns, to be kept and performed, do hereby demise and lease unto the said Lessee, its successors, administrators and assigns, for and during a term of fifty (50) years, beginning on the first day of August, A. D. 1964, that certain tract or parcel of land located in the Town of Scituate, bounded and described as follows:

Beginning at a stone bound on the southerly line of Danielson Pike so called in the Town of Scituate, said bound being Nine Hundred Sixty One (961) feet more or less easterly from the range of the easterly line of Spring Brook Road so called, as measured along the southerly line of said Danielson Pike, thence westerly along the southerly line of said Danielson Pike, a distance of One Hundred Four and 37/100 (104.37) feet, thence southerly forming an interior angle of  $81^{\circ}-04'$  a distance of One Hundred One and 23/100 (101.23) feet, thence easterly forming an interior angle of  $98^{\circ}-56'$  a distance of One Hundred Twenty One and 47/100 (121.47) feet, the last mentioned course being parallel to and One Hundred and 00/100 (100.00) feet distant from the first mentioned course, thence northerly forming an interior angle of  $81^{\circ}-04'$  a distance of One Hundred One and 23/100 (101.23) feet to the southerly line of said Danielson Pike, the last mentioned course being parallel to and One Hundred Twenty and 00/100 (120.00) feet distant from the second mentioned course, thence westerly forming an interior angle of  $98^{\circ}-56'$  a distance of Seventeen and 10/100 (17.10) feet along the southerly line of said Danielson Pike to the point of beginning, said tract or parcel containing Twelve Thousand One Hundred Forty Seven and 00/100 (12,147.00) square feet, the whole being a part of Parcel 450 as shown on Sheet A-3 of Plat of Lands Condemned by the City of Providence for Water Supply Purposes in the Town of Scituate, Rhode Island, and being further delineated on a plat entitled "City of Providence - Water Supply Board - Land in the Town of Scituate Proposed to be Leased to the Rhode Island Episcopal Convention" Dated May 26, 1964, Acc. 6269 approved by Philip J. Holton, Jr., Chief Engineer, a copy of which is attached hereto and made a part hereof.

TO HAVE AND TO HOLD the same, with all the rights and privileges thereof unto the said Lessee, its successors, administrators and assigns for and during a term of fifty (50) years from the first day of August, A.D. 1964, they yielding and paying therefor as a yearly rent, the sum of one (\$1.00) dollar, and an additional sum equal to the taxes which may be assessed thereon annually or otherwise by the Town of Scituate or other governmental body, the same to be paid within one (1) month of the assessment of said tax.

Provided always, and this lease is made upon the following express conditions:

That the said Lessee, its successors, administrators and assigns shall, during the continuance of this lease, use and occupy the aforescribed premises for the religious and charitable purposes of the Rhode Island Episcopal Convention, and for no other purpose whatsoever;

That they shall observe and abide by all statutes, laws, ordinances, rules and regulations which are now in force, or which may be hereafter enacted with respect to such occupancy;

That they shall not use or suffer said premises, or any part thereof, to be used or occupied for any unlawful business or any unlawful purposes whatsoever. And they will preserve the peace and maintain good order on said premises at all times; that they will not assign, underlet or part with the possession of the whole or any part of the demised premises without first obtaining the written consent of the Lessor, acting by and through its Water Supply Board.

It is further understood and agreed by and between the parties hereto that any buildings or other improvements now or hereafter erected on said premises are to be held at the sole risk of said lessee, its successors, administrators and assigns.

And it is further understood and agreed that upon any violation of any of the foregoing conditions or covenants, the said Lessor, by any agent duly authorized, shall be at liberty to terminate this lease, and

may thereupon lawfully, immediately or at any time thereafter, and without notice or demand, enter into and upon said premises and repossess the same as of their former estate.

And it is further understood and agreed by and between the parties hereto that if the said lessee, its successors, administrators and assigns, shall not within six months from and after the expiration or other termination of this lease remove any and all buildings, structures and other improvements now or hereafter erected on said premises by said lessee, the same shall become and be the sole and lawful property of the said lessor.

It is further understood and agreed by and between the parties hereto that all buildings and improvements erected or placed upon said land are and shall be pledged for the payment of all rents accruing or owing under this lease.

If at any time in the opinion of the Water Supply Board of the City of Providence the occupation or manner of use of the demised premises causes, or in the opinion of said Board, is liable to cause the waters of the reservoir or its river branches and tributaries to become polluted, the Water Supply Board may at any time terminate this Lease by written notice to such effect given at least 30 days prior to date of termination.





Spring Street - from Pond Street to Broad Street.


Pond Street - from Winter Street northeasterly to a point 86.07 feet from the freeway line.




