Dear Mayor Cianci:

The Providence School Department requests a waiver from the residency rule for four individuals who can fill positions in 3 critical areas in our Special Education Department: two occupational therapists, one physical therapist and a bilingual special education teacher.

The Allied Health professionals are employed full time at nearby hospitals or health care facilities. The candidates listed below own their home in a nearby area and are not prepared to incur the expense of relocating at this juncture. Ilda Pinto, the secondary bilingual teacher has children in high school and would prefer them to continue their high school years without disruption before relocating to Providence.

All of the candidates for which we are requesting a waiver are fully certificated, well experienced and have excellent references and credentials.

We feel fortunate to have attracted them to our district so that our children can receive the benefit of their training and experience.

We do not make this request without serious consideration and some hesitation. The pages that follow, hopefully will illustrate the effort that was made to recruit professionals to staff these vacancies in the special education field.

Every American urban school district is seeking the same personnel for their special needs population and are encountering great difficulty in meeting the demand. Hospitals, health care facilities, public and private, are attracting the short supply by offering higher salaries and other attractive incentives.

Therefore, we are making this request on behalf of the children who are in need of these special services.

OCCUPATIONAL THERAPY POSITIONS

You have been well aware of the lack of services for 65 special education students in need of occupational therapy during the 1993-94 school year. We are obligated by law to make-up those missed services and have had major problems maintaining contracted services for this area. We have made the following efforts:

- Mailing from me to over 250 certified occupational therapists throughout Ct., Mass, and RI
- Mailing to graduates of OT program of St. Ambrose in Iowa, and Quinnipiac in Ct.
- Contracted services attempted at RI Hospital, Meeting St. School, Rehab New England, Independence Rehab, and Newport Rehab.
- Advertisements placed in national OT journal - ADVANCE
- Teacher recruiter attended national OT conference in Boston this past month

One occupational therapist has been hired for September. Two other individuals are available to work in Providence but would require a residency waiver before hiring:

These individuals have positions and would not consider moving to Providence for a School Department position but would like to work for PSD for various reasons.

The budgetary allotment for OT contracted services for the 1994-95 school year is \$188,500. Clearly, hiring two full-time OTs is financially more prudent. Additionally, it is unlikely that we will be able to contract enough services to fill all our needs and for children to remain served.

We also can not dismiss RIDE's threat of our last compliance meeting that they would find it necessary to begin proceedings for a show-cause hearing if the positions remain unfilled.

Given the national shortage, our inability to hire for one full school year, the unlikelihood of contracting for all the hours we need, as well as the expense in doing so....Let's go for the waivers!

PHYSICAL THERAPIST

We have a candidate for the one (1) position that we have budgeted.

Without this position, we will again need to contract out services. We spent \$20,000 for this purpose this past year and anticipate such next year. To give you a sense of the demand, the individual who contracted with us for the summer increased her hourly rate from \$45 to \$75 and we had no alternative but to grant it, since he was the only bidder. Again, PTs are in demand and we need to be able to control schedules and salaries to gain the maximum benefit.

BILINGUAL SPECIAL EDUCATION POSITIONS

There are currently four (4) openings for bilingual special education positions. I believe it would be in our best interest to establish the position of bilingual special education teacher as an emergency position and obtain an "open waiver" for individuals who we need to hire when location may become a problem. There are very few candidates for bilingual special education positions and very few number of graduates from RI colleges. I am anticipating a problem recruiting and hiring.

Therefore, I believe we need to attempt for three specific waivers and one open waiver. These individuals can not be hired until the waivers are granted. Please advise as to the schedule we should follow in order to present these to the Mayor and the Finance Committee. I am concerned that we open school with all staff needed and have students lose no service time. These issues are being closely monitored by parents and RIDE and must be addressed as quickly as possible.


