


Objective

Leverage my skills in the areas of program development, project management, creating collaborative partnerships, education and community outreach to drive change that empowers individuals and organizations to reach their goals.

Skills and Accomplishments

- Enabled and supported tradesmen seeking to become independent building contractors through education, one on one consultation, guidance and referrals to other services / resources..
- One of the founders of the Latina Leadership Institute a major program of the Rhode Island Latino Civic Fund that provided training, skill development and empowered to Latino women enabling them to move into leadership roles in business and public service.
- Developed the curriculum and identified the resources for the Community Leadership Development Initiative (CLDI). Responsible for the recruitment and selection of the participants which over three years graduated 60 emerging Latino leaders.
- Served as the coordinator for the Advanced C.N.A. Program, at Bristol Community College-BCC, a workforce development training, federal funded ARRA grant, that provides intensive nursing aide training to displaced individuals.
- Created the Strategic Plan for the Parents Engagement unit at the RI Nurses Institute that provided opportunities for parents to get involved in the school life of their children.
- Developed and implemented the Latina Initiative at the Gloria Gemma Resource Foundation providing ongoing education, awareness and access to services for Latinos breast cancer patients and their families.
- Delivered American Cancer Society programs to multi-cultural, minority communities reaching under-served populations driving participation levels from almost nothing to significant involvement
- Represented the American Cancer Society before the Cancer Committee at Rhode Island Hospital, Roger Williams Medical Center and Fatima Hospital
- Instrumental in working with senior management at the American Cancer Society and Women & Infants Hospital to get signed the hospital collaboration services agreement.
- Communicated information about programs working with media outlets and directly responsible for the production and conduction of the radio program "Cancer on your Life" at the Latino Public Radio that brought comprehensive information on cancer issues to the public.
- Established on-going partnership and collaborations, at local and national levels, with non-profit agencies and organizations providing education, awareness of programs, resources, referrals and access to health care driving much higher participation of families in need.
- Mobilized Latino families to engage in the Rite-Care program through education, correcting misconceptions about the program and driving increased participation in the program.
- Conducted and continually updated community needs assessments
- Provided guidelines for recruitment underserved and displaced community members to take advantage of the non-credit health career program at Bristol Community College.
- Advocated and mediated for clients who needed bilingual assistance to resolve a wide range of problems, included: housing, cancer treatment, immigration issues and access to health care.
- Responsible for the management, budget and fiscal reporting for community programs and grants.

- Responsible of data collection for program evaluations and program improvements


