## PERSONAL PRIVILEGE

**COUNCILMAN GARAN** requests and is granted the floor on a Point of Personal Privilege and states that He is in receipt of a letter from Arthur E. Coia, International Vice President, Laborers' International Union of North America and requests the Clerk to read the same, as follows:

June 30, 1977

For the last three years, Public Service Employees', Local Union 1033 with a membership of 3,000, of which 2,200 are employed by the City of Providence have involuntarily been drawn into a fiscal controversy between the Mayor and the City Council.

Let me categorically state that Local Union 1033 does not wish to side with the Mayor against the Council or the Council against the Mayor. Our current agreement with the City has as its first principle the fact that the Agreement is entered into to facilitate the adjustment of disputes that develop between the City and its employees, and to provide, insofar as possible, for the continuous employment of labor and to establish necessary procedures for the amicable adjustment of all disputes which may arise between the City of Providence and its employees represented by the Union.

Our sole purpose is to protect the rights of our membership which places this responsibility upon our Union. We cannot stand aside and witness the unilateral arbitrary elimination of 182 positions now filled and necessary to maintain the proper level of city services to the people of Providence.

Last year Public Service Employees' Local Union 1033 after a labor dispute developed, negotiated a Successor Agreement with the City providing modest increases. The length of this agreement was based on assurances that no cutbacks or layoffs would occur during its life.

Historically, whenever the City has proposed

a cutback in personnel, that proposal was first discussed in detail with the Union. I refer specifically to the proposed reduction in the Waste Collection Division set forth in the Agreement which was then in effect on July 1, 1974.

The elimination of the 182 positions now occupied completely disregards the seniority protection afforded under the Agreement and would have the effect and cutbacks and services to the people of the City of Providence.

Hasty action by the City Council can only worsen the situation which exists today. Hasty action by the City Council last Tuesday evening almost resulted in the failure to provide for less than a 100% tax collection factor. Such a position will automatically create another deficit at the close of fiscal year 1978.

Local Union 1033 respectfully recommends that the budget and companion ordinances for fiscal 1977-78 be amended to include and restore the 182 existing positions. Local Union 1033 does not object to any savings which might result from the intention not to fill positions which become vacant through attrition.

Finally, the loss of the AA credit rating presently attributed to the City of Providence will have a dramatic effect on the City's borrowing capability and costs and it could directly effect the rating of the State of Rhode Island. It is for this reason that Local Union 1033 supports the \$4.90 per thousand tax rate increase with assurances from the Mayor that the 182 positions would be included and restored in the 1977-78 budget.

The "Pay Grades," "Steps" and "Annual Range" totals are recorded herein. All other salaries paid to City Officials and employees not in above pay grades shall be specifically specified.

Sec. 2. The minimum rate of pay for any class of position shall be payable to any person on his first appointment to the position allocated to the class, provided however, that with the recommendation of the Director of Finance and approval of the Mayor, he may enter the position at any other step in the "Pay Grade" and provided further, that if a person already in the service is transferred, he may with the recommendation of the Director of Finance and approval of the Mayor, enter the new position at the same rate of pay as he had previously received.

Sec. 3. Any employees employed in a position allocated to a class carrying minimum and maximum pay rates may be granted a pay increase from one step to the next higher step within established grade, subject to the following:

1. One "Pay Grade" step per year.

2. Recommendations for step increases shall be made by department heads or the Chairman of Bureaus or Commissioners at the time of submission of annual budget estimates, and at no other time. Such recommendations shall be made on the basis of the quality of work and the seniority of individual employees.

3. The Director of Finance shall review such proposed step increases for availability of funds and conformity to the provisions of this Ordinance, and shall recommend approval or disapproval of the increase to the Mayor.

4. An employee entering the city service shall be eligible for a step increase on the first

day of the succeeding January, April, July or October next following the completion of twelve months of service by said employee in accordance with the provisions of sub-sections 1, 2, 3, and 5 of this Section.

5. Any employee who is transferred from a position not carrying a minimum and maximum pay rate to one that carries a minimum and maximum pay rate shall receive either his present salary or the minimum salary of the new position, whichever is greater, but in no case shall the new salary exceed the maximum salary of his new position.

6. Increased compensation received by an individual as the result of promotion from a lower to a higher class shall not be deemed a step increase in the sense of the term as used in this section and in the event of promotion shall automatically receive the minimum salary for the class to which he has been promoted. If such minimum salary is the same or less than the salary he received prior to his promotion, he may receive a salary which shall be one full increment higher than his prior salary, but in no case to exceed the maximum.

Sec. 4. A given rate of pay as expressed in the compensation plan may be commuted to weekly, daily or hourly rate and established by a department head or Chairman of a Bureau or Commission with the approval of the Mayor and the Director of Finance, as the rate of pay for employees of a particular class: provided, however, that all employees of a given class in a

given unit of a department shall be paid on the same basis, excepting part-time and temporary employees.

Sec. 5 No Officer or employee of the City shall issue a check for payment of, or pay any salary or compensation to any person holding, or claiming to hold a position in the classified service, unless the Personnel Director shall have first certified that the persons named on the payroll or account of such compensation have been appointed and are employed in accordance with this Ordinance.

Sec. 6. Chapter 1976-36 of of the Ordinance approved October 29, 1976 with all amendments thereto is hereby repealed.

Sec. 7. This Ordinance shall take effect upon its passage.
