Resolution Requesting the City Solicitor to Prepare, Cause to be Introduced and to Urge Passage at the 1981 Session of the General Assembly of an "Act to Amend the Public Laws 1923 and 1970, as Amended to Waive the Requirement that the City of Providence Contribute to the Employees' Retirement Fund in Fiscal Year 1981, Provided that adequate Funding is Reserved in Fiscal Year Commencing 1982."

COUNCILMAN ADDISON moves that the Resolution be Passed.

Whereas, The Mayor of the City of Providence has previously indicated that he would implement lay-offs of city personnel substantially in excess of the One Hundred Eighty Three (183) employees who allegedly have been laid off; and

Whereas, The City faces a serious and immediate fiscal crisis, and

Whereas, It would appear that City services could be carried out despite additional lay-offs;

Now, Therefore, Be It Resolved, That the Committee on Finance request the Mayor to implement additional lay-offs pursuant to his originally announced plan forthwith.

Read and Passed, on motion of COUNCILMAN ADDISON, seconded by COUNCILMAN STRAVATO.

The motion for Passage is Sustained.

Resolution Requesting the City Solicitor to Prepare and Cause to be Introduced in the General Assembly, Legislation, If Necessary, Permitting the City of Providence to Charge Service Fees to All Property Tax Exempt Institutions and Property Owners Based Upon Certain Provisions.

Whereas, The City of Providence has for some time, been providing services to various institu-

tions which are exempt from City real property taxes, and

Whereas, The cost of such services is a substantial unreimbursed cost to the City, which must be born by all non-exempt property taxpayers, and

Whereas, There is need to put the City's operations on a sounder financial basis and allocate cost of services more realistically to the recipients of such services,

Now, Therefore, Be It Resolved, (1) that, if enabling legislation is necessary, the City Solicitor prepare and cause to be introduced in the General Assembly, enabling legislation permitting the City of Providence to charge service fees to all property tax exempt institutions and property owners in the City of Providence based on the cost of provision by the City of fire, police, highway, street cleaning, snow removal and street lighting expenditures, such service fees to be based on the appraised value of the property owned by such exempt institutions and property owners in the City of Providence as a percentage of the assessed value of all properties located in the City of Providence, such service fees to be determined as follows:

(a) The cost of provision of police and fire protection, highway and street maintenance and construction, snow removal and street lighting shall be determined;

(b) The assessed value of all real property, including the assessed value of tax exempt real property in the City of Providence shall be determined;

(c) The tax rate for the above services shall be determined by dividing the cost of provision of such services throughout the City by the total assessed value of real property as defined above; and

(d) The service fee to be paid by each tax

exempt institution and property owner shall be determined by multiplying said tax rate by the assessed value of the real property owned by said institution or property owner, and

(2) That if enabling legislation is not necessary to impose said fees, that the City Solicitor, in consultation with the Finance Director and the Committee on Finance, prepare Ordinances implementing the foregoing.

Resolution Requesting the Committee on Finance to Advise the Mayor's Financial Advisory Committee that the City Council Requests a Management Study of All City Operations and further Requesting the Rhode Island Expenditures Council and the Greater Providence Chamber of Commerce to Commence Organization of such Study and to Indicate Whether and to What Extent and Expenditure of City Funds will be Necessary to Conduct such Study.

Whereas, The City of Providence's current financial crisis is likely to lead to a significant increase in real property taxes payable by the taxpayers of the City of Providence; and

Whereas, The City's financial problems in part arise out of an absence of management economies and efficiencies in collection of revenue and provision of services and management of funds; and

Whereas, The Mayor's Financial Advisory Committee has recommended a management study of all city operations;

Now, Therefore, Be It Resolved, That the Committee on Finance of the City Council is hereby requested to advise the Mayor's Financial Advisory Committee that this Council requests that such a management study take place and that this Council will cooperate fully with the persons conducting such study and will advise all

city department directors of this Council's support for said study and request their cooperation with same and that this Council requests the Rhode Island Public Expenditures Council and the Greater Providence Chamber of Commerce to commence organization of such study forthwith and indicate to this Council whether and to what extent and expenditure of City funds will be necessary to conduct such study.

Resolution Requesting the City Solicitor to Prepare and Cause to be Introduced in the General Assembly, Legislation Providing for Reimbursement by the State of Rhode Island to the City of Providence of the Cost of Services Provided to Tax Exempt Institutions and Properties Located in the City of Providence.

Resolved, That the City Solicitor is hereby requested to prepare and cause to be introduced in the General Assembly of the State of Rhode Island legislation providing for reimbursement by the State of Rhode Island to the City of Providence of the cost of services provided to tax-exempt institutions and properties located in the City of Providence, such legislation to be substantially based on legislation presently in existence in the State of Connecticut, a copy of which is attached hereto as Exhibit A.

Resolution Urging and Authorizing the City Collector to Impose a Penalty, by way of

Interest, on the Tax, in the Amount of Twelve Per Cent (12%) Per Annum Upon Any Tax Not Paid at the Appointed Time.

Whereas, The past practice of the City Collector has been to levy a late fee of eight (8%) per cent per annum for past due taxes;

Whereas, Prudent management of municipal finances now demands said levy be raised to a rate of twelve (12%) per annum;

Whereas, All efforts should be undertaken to insure the punctual payment of municipal taxes;

Whereas, 44-5-9 of the General Laws of the State of Rhode Island, 1956 (1968 Re-enactment as amended), provides for the imposition of penalties up to an including twelve (12%) per cent per annum for the late payment of taxes;

Now, Therefore, Be It Resolved, That the City Collector of the City of Providence is urged and authorized to impose a penalty, by way of interest, on a tax, in the amount of twelve (12%) per cent per annum upon any tax not paid at the appointed time.

Resolved, That the City Solicitor is hereby requested to Prepare, Cause to be Introduced and to Urge Passage at the 1981 Session of the General Assembly of the State of Rhode Island of an Act for Immediate Consideration for Enactment of Enabling Legislation to Implement A Public Safety Fee:

To be assessed to all existing tax exempt property in the City of Providence. The rate shall be fixed at Twenty (0.20) Cents per square foot of property.

First five levels of all existing buildings on property are allowed as land mass. Additional levels shall be assessed at a rate of Ten (0.10) Cents per square foot of floor area on remaining levels.

Now, Therefore, Be It Resolved, That this Act shall take effect upon its passage and to be assessed this fiscal year at Twenty-Five percent (25%) for the last quarter judgment and full year assessments thereafter.
