That certain parcel of land situated in the City of Providence,
State of Rhode Island bounded and described as follows:

Beginning at a point said point being the northwesterly corner
of the parcel herein described parcel, also being the northeasterly
corner of Lot 207 on Assessors Plat 37 as assessed December 31, 1973 and
being one hundred sixty eight (168 \pm) feet more or less easterly of the
easterly line of Messer Street and the southerly line of Marvin Street;

thence running in an easterly direction bounded northerly by
the said line of Marvin Street a distance of sixty seven and 6/10 (67.6 \pm)
feet more or less to the northwesterly corner of Lot 182 on said
Assessors Plat 37, and a corner;

thence turning and running in a southerly direction bounded
easterly by said Lot 182 a distance of one hundred forty two and 5/10
(142 \pm) feet, more or less to Lot 171 on said Assessor's Plat 37 and a
