

## CONCERNED PARENTS AND TEACHERS:

Dear Sirs:

As concerned parents of students in the trainable program at the Almy Street School we are writing this letter to voice our opposition to the closing of the Almy Street School as of September, 1974 thru 1975.

1.) The students feel when they leave Kenyon Street School (age 16) and move on to Almy, that they have graduated. In a sense they have. They are sixteen to twenty-one years of age and they know this, to house them with grade school children is a step backwards emotionally.

2.) At Almy they are in a clean bright building which is set up to teach cooking, selfcare, how to use a clothes washer and dryer, work in a workshop in preparation for a future job, how to handle money and use a bank. They also have a pre-reading and math course.

3.) The only reason we could understand for the closing of Almy is if the city fathers saw fit to enlarge the vocational training program (then we would need a larger building) for the trainable students so that they could learn a variety of job skills other than factory oriented. What about gardening, green-house, custodial work in local hospitals, etc:

4.) Money has been spent on fixing Almy if money is spent to fix Kenyon Street School to suit Almy's needs. It's like putting money down the drain.

5.) The teachers and students are very happy with the school at Almy. The teachers have certainly spent a lot of time teaching these children, who ten years ago were thought to be unteachable.

Please reconsider the closing of the school. Come visit the Almy School and see what these students are doing. They take great pride in their work.

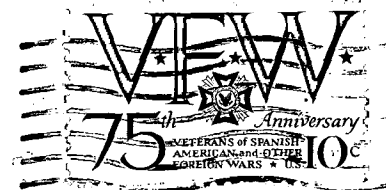
