To the Honorable City Council of Providence

Gentlemen:

I have the honor to report on several resolutions referred to me by your Honorable Body concerning the establishment of additional crossing guard posts.

The staff of the Police Department has carefully studied these proposals and has given qualified recommendations of approval, pointing out however, that other crossings in the city have more children passing. We lack definite criteria for determining the need of a crossing guard at a given point, since no administrator can arbitrarily say that twenty-five children require a crossing guard and twenty-four do not.

On two previous occasions, September 12, 1963 and April 15, 1964, I have called the attention of your Honorable Body to the mushrooming costs of providing additional crossing guards. The facts presented in those reports are still valid.

I recommend that your Honorable Body increase the authorized number of crossing guards by four (4), from ninety (90) to ninety-four (94). This will allow one guard each for the intersections of Bucklin and Carter Streets and Roger Williams Avenue and Reservoir Avenue, and two guards for the crossings in route from Codding Court to Kenyon Street School, one at Cranston and Knight and another at Westminster and Knight. An alternate proposal provides one guard for the Codding Court area to accompany the children from a central point to the crossing at Westminster and Knight. This latter,

with the support of the local parents' group which submitted the petition to the council, would save the taxpayers the outlay for one guard and her uniform.

The additional appropriation for four guards would be about \$6,050 per year and \$450 the first year for uniforms.

As soon as your Honorable Body changes the Classification Ordinance and provides the necessary funds, I will direct the Chief of Police to implement such action.



Gentlemen:

On July 2, 1964 the Providence Redevelopment Agency reported the proposed sale of land within the Central-Classical Project No. R. I. R-2 to Ebenezer Baptist Church. The proposed sale of 42,887 square feet was reported to the City Council at a unit price of \$.30 per square foot for a total sales price of \$12,866.10. Subsequent to the report, it was discovered that the unit price of \$.30 per square foot was in error and should have been \$.23 per square foot. This latter unit price, which is the Federally approved disposition price, now results in a new total sales price of \$9,864.01.

Therefore, we request you to amend the original report to reflect the change in the sales price.
