## PERSONAL PRIVILEGE

**COUNCILMAN DeLUCA requests to speak on a Point of Personal Privilege and states:**

"Mr. President. We addressed this matter last week with limited and unsatisfactory results. The Resolution we passed was very limited and touched on the conduct of only two individuals. They have not acted on that Resolution.

I think that the City Council needs a complete investigation of the Police Detail Account. We do not wish to interfere in any way with the other

investigations. This meeting was called to deal with the whole matter and to assert the Council's powers of oversight over the Administration, according to the City Charter Sections 402 and 403. Since the last Council Meeting, more information has come out in the Providence Journal. The appearance of a cover-up by the Mayor and his Administration has not been dispelled.

The Mayor and the involved Officials have completely ignored this Council. The Commissioner of Public Safety has been communicating with the Press but not with the City Council.

The City denies the Providence Journal access to public documents. The only information this Council has is from the Providence Journal, individual Council members on this floor have asserted that the Attorney General would carry out a complete investigation of the Police Detail Account and so we did not need the supervision of the Internal Auditor.

Why hasn't the Council received a copy of the Internal Affairs report?

Why don't we have copies of the two prior investigations of the Police Detail Account?

What happened to these reports and who has them? (They are public documents).

Why was the Journal denied access?

Do we have access to these records?

The refusal of the Mayor to have City Officials step aside pending this investigation only fuels the scandal.

The Commissioner of Public Safety should have brought this problem to the attention of the City Council.

I want all officials involved in this matter at a public hearing to answer the questions of this Council. (As Section 403 of the Charter requires).

I recommend we appoint the Chairman of the Committee on Finance, the Majority Leader, the

Minority Leader as a Committee, to represent the Council in this matter working with the Internal Auditor to secure the reports we need and keep the Council informed on the progress or lack of progress in the State's Investigation.

Then we can make decisions on what Council has to do to fulfill its duty under Sections 402 and 403 of the City Charter.

Now, a Forensic Audit. Such assertions were not backed up by any official communication to this Council from the A.G.'s Office, nor from the Administration. This Council knows nothing official to provide a foundation for the exercise of one of its most important duties — Investigative Oversight and its powers to remove City Officials for neglect of duty or dishonest conduct. That is why we called this meeting.

A. To pass Resolutions covering the entire Police Detail Account and satisfy the intention of the Council to have this whole matter investigated.

B. To establish a line of communication between the Council and the State so that the exercise of our powers does not interfere with the work of the A.G.'s Office or the State Police.

We do not want to interfere with the State Investigation. But, we want to be certain that there will be a complete investigation and that the material is made available to them.

## PRESENTATION OF RESOLUTIONS

COUNCILMAN GLAVIN moves that the Resolutions be Severally Read and Collectively Passed.

This motion is seconded by COUNCILMAN DeLUCA.

COUNCILMAN GLAVIN moves that "Resolution Requesting the Auditor General of the State of Rhode Island to conduct or cause to be conducted a Forensic Audit of the Providence Police Detail Account for the years 1989 to 1994" be amended to read as follows: "Resolution that the Providence City Council does hereby request the Joint Committee on Legislative Services to request the Auditor General of the State of Rhode Island or his office to conduct or cause to be conducted, a Forensic Audit of the Providence Police Detail Account pursuant to the Statute of Limitations".

This motion is seconded by COUNCILMAN DeLUCA.

COUNCILMAN GLAVIN thereupon moves that the Resolution be Read and Passed, as Amended.

This motion being seconded by COUNCILMAN DeLUCA is Put to Vote and Passed, by a Voice Vote.

COUNCIL PRESIDENT PETROSINELLI desires to be recorded as voting "No".

The motion for Passage, as Amended, is Sustained.

COUNCILMAN GLAVIN moves that "Resolution Requesting the Attorney General of the State of Rhode Island to investigate the Providence Police Detail Account for the years 1989 to 1994" be Layed on the Clerk's Desk.

This motion being seconded by COUNCILMAN FENTON is Put to Vote and Passed by a Voice Vote.

COUNCILMAN DeLUCA desires to be recorded as voting "No".

The motion to Lay on the Clerk's Desk, is Sustained.
