No. 415 **AN ORDINANCE** AMENDING CHAPTER 9 OF THE CODE OF ORDINANCES ENTITLED "FIRE PREVENTION AND PROTECTION," SECTION 9-101

Approved JULY 26, 2007

Be it ordained by the City of Providence:

SECTION 1. Chapter 9 of the Code of Ordinances of the City of Providence is hereby amended in part to read as follows:

Sec. 9-101. Fees.

Each person receiving emergency medical services in the city shall be billed for the following fees, if applicable:

Amending Section 9-101 **EMS rates**

Like many medical procedures, EMS fees are driven by the rates set by the federal government through the Medicare program. The changes outlined in this amendment add and delete categories and align the fee structure so that the city does not forego compensation permitted.

These fees are charged to non resident users of the City's EMS services. Costs are borne by insurance carriers.

Increasing these fees will add additional revenue of \$250,000/yr.
