PETITION TO THE CITY COUNCIL

TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

The undersigned respectfully petitions your honorable body

1. That the petitioner has acquired a parcel of land in the City of Providence, situated between Branch Avenue and Winchester Street.

2. That there has heretofore extended southwesterly from Branch Avenue to Vicksburg Street a right of way called Pepper Street, as shown on that plat entitled "Wanskuck Village Plat, Providence, R. I. By Waterman Engineering Co. Oct. 1946 Scale 1" = 50' " which plat is recorded in the Office of the Recorder of Deeds of the City of Providence in Plat Book 41 at page 59.

3. That said Pepper Street forms the northwesterly boundary of the petitioner's parcel of land.

4. That the portion of Pepper Street between Branch Avenue and Winchester Street has never been used by the public; that it has never been graded, curbed or paved and that it is continually being used as a depository for debris and unregistered and/or abandoned motor vehicles.

5. That the petitioner and his predecessors in title have paid taxes thereon.

WHEREFORE, the petitioner prays the City Council to determine that the portion of said Pepper Street between Branch Avenue and Winchester Street has ceased to be useful to the public, to order the abandonment of the same as a public highway and to take such further action as it shall deem to be desirable.



This private right-of-way contains a private sewer line that services the entire "Wanskuck Village Property".

It is the opinion of this Department that the City of Providence through the City Council has no jurisdiction to order an abandonment of a private right-of-way.

Subject: Referral No. 1760 - PETITION FOR ABANDONMENT OF PEPPER STREET

Gentlemen:

This referral from the Committee on Public Works is a petition for the abandonment of a portion of Pepper Street which runs approximately from 796 Branch Avenue to Winchester Street in Assessor's Plat 102.

A tour for photography and inspection revealed that the land represented in the petition as Pepper Street is an unpaved uncurbed alley blocked by fences from adjoining property which cross it midway between Branch Avenue and Winchester Street. The street follows a 16% grade sloping toward Branch Avenue. The neighborhood south of Branch Avenue is residential and in fair to good condition. The area north of Branch Avenue is the site previously occupied by the Wanskuck Mills.

Research and consultation with the Public Works Department revealed that Pepper Street does not exist as a public highway. It is privately owned and contains an easement for a main sewer line which services the Wanskuck village area. Since the City has no jurisdiction over this land, it would appear that it cannot be abandoned. Furthermore, the sewer should positively be protected from any activity involving building or excavation. Therefore,






