WHEREAS, The City Council believes that the Study of City Tax Revenues is important to the future deliberations of the City Council, and

WHEREAS, That pursuant to Rule 27 of the Rules of the City Council a Study Commission on City Tax Revenues is hereby created, and

WHEREAS, That the purpose and charge of said Study Commission shall be to advise the City Council on Tax Revenues with a goal of promoting quality revenues, and

WHEREAS, That said Study Commission shall consist of Nine (9) Members appointed by the President of the City Council including Three (3) of the City Council, One (1) Mayoral Appointment, One (1) State Representative, One (1) State Senator, Two (2) Business Community Representatives and One (1) Citizen of the General Public, and

WHEREAS, That the Chairperson and Vice-Chairperson of said Study Commission shall be appointed by the President of the City Council,


