WHEREAS, Council President Sabina Matos, pursuant to Section 406 of the Providence Home Rule Charter of 1980 and Rule 3 of the Rules of the City Council, requested the City Clerk, in writing, to Call a Special Meeting of the City Council to be held on Wednesday, July 3, 2019, at 4:30 o'clock P.M., in the City Council Chamber, Third Floor, City Hall for the purpose of Enacting the following:

An Ordinance Amending Ordinance No. 368 of Chapter 2018-30, Adopted July 2, 2018 Providing for the Assessment and Collection of 2018 Taxes in a Sum Not Less Than Three Hundred Fifty One Million Eight Hundred Twenty Six Thousand and Six Hundred Forty Eight Dollars (\$351,826,648) and Not More Than Three Hundred Fifty Seven Million Nine Hundred Eighty Four Thousand and Five Hundred Fifty Nine Dollars (\$357,984,559) Being Based on a One Hundred Percent (100%) of the 2019-2020 Fiscal Year Tax Collections, and Setting the Rates for Fiscal Year 2020.




