# RESOLUTION OF THE CITY COUNCIL

No. 212

Approved March 9, 1979

WHEREAS, Presently pending before the House Committee on Judiciary an Act to prohibit the use of deadly force by police officers in effecting arrests except for felonies wherein the suspect used or threatened to use deadly force of where it is believed that a substantial risk of serious bodily harm or death would result from a delay of arrest; deadly force would in no case be justified if its use created a substantial risk or harm to innocent persons,

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence, Rhode Island hereby endorses House Bill 79-H 5638 relating to the Use of Deadly Force by Policemen.
